### AN ACT to amend the Racing and Gaming Act 1952.

[Royal Assent 2 May 1986]

**BE** it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**1**—This Act may be cited as the *Racing and Gaming Amendment Act (No. 2) 1986*. Short title.

Principal Act.

**2**—In this Act, the *Racing and Gaming Act 1952\** is referred to as the Principal Act.

Amendment of section 3 of Principal Act (Interpretation).

**3**—Section 3 of the Principal Act is amended by omitting the definition of “ Racing Assistance Fund ”.

Amendment of section 21 of Principal Act (Conditions upon which clubs may be registered).

**4**—Section 21 (1) of the Principal Act is amended by omitting paragraph (iv).

Amendment of section 40A of Principal Act (Appointment of stipendiary stewards by Directorate).

**5**—Section 40A (1) of the Principal Act is amended by omitting “ and the chairman of the stipendiary stewards of that body ”.

Insertion in Principal Act of new section 42.

**6**—After section 41 of the Principal Act, the following section is inserted:—

Effect of suspension or disqualification.

**42**—(1) Where, pursuant to any decision or determination by a horse-racing club, harness racing club, greyhound racing club, or of the stewards of such a club, or an appropriate controlling body, a person is whether with or without limitation as to time, disqualified or suspended from acting in any prescribed activity he is, while he is so disqualified or suspended, disqualified or suspended from acting in any other prescribed capacity and shall be deemed to be so disqualified or suspended under the Rules of Racing relating to persons acting in that other capacity.

(2) In this section “ prescribed capacity ” means the capacity as—

- (a) owner or trainer of a galloping-horse or a trotting-horse, or a dog used for greyhound racing; or
- (b) rider or driver of a galloping-horse or a trotting-horse.

Repeal of section 43 of Principal Act (Fund for the relief of jockeys and their dependants).

**7**—Section 43 of the Principal Act is repealed.

**8**—Section 44A of the Principal Act is repealed.

Repeal of section 44A of Principal Act (Times for starting race meetings).

**9**—Division IV of Part III of the Principal Act is repealed.

Repeal of Division IV of Part III of Principal Act.

**10**—Section 69 (4) of the Principal Act is amended as follows:—

Amendment of section 69 of Principal Act (Duties of bookmakers).

(a) by omitting from paragraph (f) “ and verified by statutory declaration ”;

(b) by omitting from paragraph (g) “ and verified by statutory declaration ”.

**11**—Section 74 (5) of the Principal Act is amended by omitting “ the credit of the fund established by section 43 or of the Racing Assistance Fund,” and substituting “ the Directorate for the purposes specified in section 9 (1) (b) of the *Racing Act 1983* ”.
