AN ACT to amend the Roads and Jetties Act 1935.

[30 November 1977]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1—(1) This Act may be cited as the Roads and Jetties Act (No. Short title and citation.
 2) 1977.
- (2) The Roads and Jetties Act 1935*, as subsequently amended, is in this Act referred to as the Principal Act.

State Highways Trust Fund.

- 2 Section 4 of the Principal Act is amended—
- (a) by omitting paragraph (c) of subsection (2);
- (b) by omitting subsection (3) and substituting the following subsections:—
 - "(3) The Transport Commission shall, as and when directed by the Treasurer, pay to the Treasurer, to the credit of the Consolidated Revenue—
 - (a) all moneys received by it in each financial year by way of—
 - (i) motor taxes after the deduction therefrom of the sums specified in subsection (3A); and
 - (ii) revenue derived from the source mentioned in subsection (2) (e); and
 - (b) the moneys received by it in each financial year from the source mentioned in subsection (2) (d).
 - "(3A) The following are the sums referred to in subsection (3) (a) (i):—
 - (a) All sums paid by the Transport Commission by way of refunds of motor taxes pursuant to section 4 (5) of the Motor Vehicles Tax Act 1917;
 - (b) All payments required to be made by the Transport Commission by way of rebates for the purposes of section 9 of that Act; and
 - (c) The refunds made pursuant to section 9 (1) (e) of the Transport Act 1938.";
- (c) by omitting from subsection (4) the words "paragraphs (b), (c), (d), and (e) of subsection (2) of this section" and substituting the words "paragraphs (b), (d), and (e) of subsection (2)"; and
- (d) by omitting subsection (7).

Operation of amendments.

3 The amendments to the Principal Act made by section 2 apply in respect of the financial years commencing after 30th June 1977.
