AN ACT to amend the Roads and Jetties Act 1935 to provide for the crediting to the State Highways Trust Fund of monthly sums on account of the amounts collected by way of licence fees under the Petroleum Products Business Franchise Licences Act 1981.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the *Roads and Jetties Amendment Act* 1981. Short title.

2—This Act shall commence on the date on which the *Petroleum Products Business Franchise Licences Act 1981* commences.

Principal Act.

3—In this Act, the *Roads and Jetties Act 1935** is referred to as the Principal Act

4—(1) Section 4 (2) of the Principal Act is amended by inserting the following paragraph after paragraph (b):—

(c) as soon as practicable after the end of each month a sum equal to 90 per cent of the amount collected by way of licence fees under the *Petroleum Products Business Franchise Licences Act 1981* during that month;

(2) Section 4 of the Principal Act is further amended by inserting the following subsection after subsection (2):—

(2A) A sum required to be credited to the Fund by subsection (2) (c) shall be paid by the Treasurer out of the Consolidated Revenue Fund, and the sum so payable is accordingly, by virtue of this subsection, appropriated to the extent necessary.
