# AN ACT to amend the Shops Act 1925. [28 November, 1945.]

A.D. 1**945.** 

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the Shops Act 1945.

Short titl and citation.

(2) The *Shops Act* 1925\*, as subsequently amended, is in this Act referred to as the Principal Act.

### Shops.

A.D. 1945.

Closing hours: Butchers' shops.

- 2 Section nine of the Principal Act is amended—
  - (a) by omitting the words "Butchers' shops" to "Fridays, and" in subsection (1); and
  - (b) by adding at the end thereof the following subsection:—
    - "(2) Butchers' shops in the cities of Hobart and Launceston and in the municipality of Glenorchy shall be closed at five of the clock in the afternoon of the first four week-days, and at six of the clock in the afternoon of Friday, in each week, and shall remain closed until six of the clock in the morning of the following Monday.".

Chemists may supply medicines, &c.

- 3 Section ten of the Principal Act is amended—
  - (a) by omitting the words "half-past seven and half-past eight of the clock in the afternoon of any day" in subsection (1) and substituting therefor the words "seven and eight of the clock in the afternoon of any Saturday, Sunday, or bank holiday (within the meaning of the Bank Holidays Act 1919\*)"; and
  - (b) by inserting after subsection (1) the following subsection:—
    - "(1A) Except as provided by subsection (1), chemists' and druggists' shops in the city of Hobart and the municipality of Glenorchy shall be closed at six of the clock in the afternoon of the first four week-days, and at nine of the clock in the afternoon of Friday, in each week, and shall remain closed until six of the clock in the morning of the following Monday.".

Sale of tobacco &c.

- 4 Section fourteen of the Principal Act is amended by inserting after subsection (2) the following subsection:—
- "(2A) Any person who contravenes the foregoing provisions of this section shall be liable to a penalty of ten pounds.".

**5** Notwithstanding anything contained in section nine of the Principal Act or in the *Shops Act* 1937<sup>†</sup>, hairdressers' shops and tobacconists' shops in the city of Hobart and the municipality of Glenorchy shall be closed at six of the clock in the afternoon of the first four week-days, and at seven of the clock in the afternoon of Friday, in each week, and shall remain closed until six of the clock in the morning of the following Monday.
