- (f) by adding at the end of that section the following subsection:----
 - "(6) Subject to the directions of the Treasurer, the proceeds of the sale of any land which is sold pursuant to this section shall be credited to such of the funds or accounts under the control of, or kept by, the Commission for the purposes of this Act as the Minister may approve.".

Validation of certain acquisitions, &c. **3**—(1) Every acquisition of land made by the Commission for the purpose of a State forest, or for the purpose of providing access thereto or to any timber reserve, which would have been valid if the *Forestry Act* 1946 had not been enacted and which was completed before the commencement of this section shall be effective to vest the land in the Crown for the purpose of the acquisition and any compensation paid or payable in respect thereof shall be deemed, for all purposes, to have been lawfully paid, or, as the case made be, to be lawfully payable.

(2) Any acquisition begun by the Commission for any purpose mentioned in subsection (1) of this section but which is not completed before the commencement of this section may be completed as if the *Forestry Act* 1946 had not been enacted, and, upon being completed, shall have the same effect for all purposes as if it were an acquisition to which subsection (1) of this section relates.

AN ACT to apply out of the Consolidated Revenue a sum for the Service of the year ending the thirtieth day of June, one thousand nine hundred and fiftythree. [30 April, 1952.]

B^E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title.

1 This Act may be cited as the Supply Act 1952-53.

2 There shall and may be issued and applied towards Issue and making good the supply hereby granted to Her Majesty for £2,186,950. the service of the year ending the thirtieth day of June, one thousand nine hundred and fifty-three, the sum of two million, one hundred and eighty-six thousand nine hundred and fifty pounds out of the Consolidated Revenue, for the purposes and services expressed in the schedule to this Act: and the Treasurer is hereby authorised and empowered to issue and apply the moneys authorised to be issued and applied.

3 The said sum shall be available to satisfy the warrants Sum avail-under the hand of the Governor in respect of any purposes and purposes are forth in services set forth in the said schedule. schedule.

4 The Treasurer shall be allowed credit in his accounts Credit to be for any sums of money paid by him in pursuance of any Treasurer in such warrant as aforesaid; and the receipts of the respective accounts. persons to whom the same are so paid shall be a full and valid discharge to the Treasurer in passing his said accounts for any such sums as are therein mentioned, and he shall receive credit for the same accordingly.
