AN ACT to amend the *Audit Act 1918*.

[11 November 1966.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *Audit Act 1966*.

(2) The *Audit Act 1918*, as subsequently amended, is in this Act referred to as the Principal Act.

(3) This Act shall be deemed to have commenced on the first day of September 1966.

AN ACT to amend the *Superannuation Act 1938*.

[11 November 1966.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title.
and citation.

1—(1) This Act may be cited as the *Superannuation Act* 1966.

(2) The *Superannuation Act* 1938, as subsequently amended, is in this Act referred to as the Principal Act.

Interpre-
tation.

2 Section three of the Principal Act is amended—

- (a) by adding at the end of paragraph (a) of the definition of “employee” in subsection (1) thereof the words “(not being a person to whom subsection (1A) of this section applies)”; and
- (b) by inserting after subsection (1) thereof the following subsection:—

“(1A) Notwithstanding anything in the definition of ‘employee’ in subsection (1) of this section, the following persons shall be deemed to be employees within the meaning and for the purposes of this Act, namely:—

- (a) Persons employed as student nurses by the board of management or other authority or person having the management and control of a public hospital;
- (b) Persons employed as student nurses (geriatric) at the St. John’s Park Hospital; and
- (c) Persons employed as student nurses (psychiatric) at the Lachlan Park Hospital,

whether those persons are so employed at the commencement of this subsection or become so employed after that commencement.”.

3 Section twenty-six of the Principal Act is amended by omitting from paragraph (a) of subsection (4B) thereof the words “seventy-eight dollars” and substituting therefor the words “four hundred and sixty-eight dollars”.

4 Section thirty-seven of the Principal Act is amended by omitting from subsection (1) thereof the words “one hundred and thirty dollars” and substituting therefor the words “five hundred and twenty dollars”.
