2-(1) The Treasurer may issue out of the Loan Fund application of for the service of the year ending on the thirtieth day of June 1970, sums of money, not exceeding in the whole the sum of \$15,000,000 for any purpose that-

- (a) is specified in the first schedule to the Loan Fund Appropriation Act 1968-1969; or
- (b) should, in the opinion of the Governor, be carried out in the public interest and is recommended by the Treasurer as properly to be paid for out of the Loan Fund.

(2) The application of each sum for the purposes of this section shall be determined by the Governor without any authority other than this section.

3 The Treasurer may arrange for the borrowing on behalf of the State, in accordance with the Financial Agreement, of such sums as are required for the purposes of this Act.

4—(1) The Treasurer shall incorporate all moneys issued and applied, or to be issued and applied, under this Act in the estimates of expenditure from the Loan Fund to be submitted to Parliament for the year ending on the thirtieth day of June 1970 as if their issue and application were to be authorized afresh by the ordinary Loan Fund Appropriation Act for that year.

(2) If the issue and application of any money under this Act is not so authorized it shall be deemed on the passing of that Act to have been done without lawful authority.

AN ACT to apply out of the Consolidated Revenue a sum for the service of the year ending on the [30 June 1969.] thirtieth day of June 1970. BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :---

1 This Act may be cited as the Supply Act 1969-1970.

2 There may be issued and applied towards making good the supply hereby granted to Her Majesty for the service of the year ending on the thirtieth day of June 1970 the sum of \$23,473,900 out of the Consolidated Revenue, for the purposes and services expressed in the schedule, and the Treasurer is authorized to issue and apply the moneys so authorized to be issued and applied.

No. 3 of 1969.

AN ACT to amend the Agent-General Act 1911. [25 July 1969.]

B^E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title, **1**citation, and commencement.

1-(1) This Act may be cited as the Agent-General Act 1969.

(2) The Agent-General Act 1911, as subsequently amended, is in this Act referred to as the Principal Act.

(3) This Act shall be deemed to have commenced on the second day of February 1967.
