1 This Act may be cited as the Supplementary Appropriation Act 1954-55.

2 The sum of £139,941 2s. 6d., that has been issued from Appropriathe Consolidated Revenue for the service of the year ended £139,941 on the thirtieth day of June 1955, shall be deemed to have 2s. 6d. been appropriated, as from the first day of July 1954, for the purposes and services expressed in the schedule.
