## SUPPLEMENTARY APPROPRIATION 1957-1958.

## No. 59 of 1958.

AN ACT to appropriate a further sum from the Consolidated Revenue for the service of the year ended on the thirtieth day of June 1958. [26 November 1958.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as the Supplementary Appropriation Act 1957-1958.
