from that Act provisions relating to the branding of stock as a consequence of the enactment of the Stock (Brands and Movement) Act 1984 and for other purposes.

[Royal Assent 18 April 1984]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title.

1—This Act may be cited as the Stock Amendment Act 1984.

Commencement.

- **2**—(1) Except as provided in subsection (2), this Act shall commence on the day on which it receives the royal assent.
- (2) Sections 4, 7, 8, and 9 shall commence on the same day as that fixed by proclamation under section 2 (2) of the *Stock* (*Brands and Movement*) Act 1984.

Principal Act.

3—In this Act, the *Stock Act* 1932* is referred to as the Principal Act.

Amendment of section 5 of Principal Act (Powers and duties of inspectors).

4—Section 5 (1) (b) of the Principal Act is amended by inserting ", if any regulations for the purposes of section 62 (2) (l) (i) are in force "after "stock".

Amendment of section 14 of Principal Act (Appeals in respect of assessments under section 13).

5—Section 14 (3) of the Principal Act is amended by omitting ", unless he dismisses the appeal,".

Amendment of section 19B of Principal Act (Appeals in respect of assessments under section 19A (3)).

6—Section 19B (3) of the Principal Act is amended by omitting , unless he dismisses the appeal,".

Repeal of Part VII of Principal Act (Stock brands).

7—Part VII of the Principal Act is repealed.

Repeal of section 54 of Principal Act (Offences relating to brands and branding). 8—Section 54 of the Principal Act is repealed.

Amendment of section 62 of Principal Act (Regulations).

9—Section 62 (2) (*l*) (i) of the Principal Act is amended by omitting "Part VII" and substituting "or under the *Stock* (*Brands and Movement*) Act 1984".
