AN ACT to amend the Supreme Court Act 1959 to revive the office of Assistant Deputy Registrar of the Supreme Court.

[Royal Assent 28 November 1979]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the Supreme Court Amendment Act Short title. 1979.

Commencement.

2—This Act shall commence on the 7th day after the date of assent to this Act.

Principal Act. **3**—In this Act, the Supreme Court Act 1959* is referred to as the Principal Act.

Amendment of section 5J of the Principal Act (Registrar, Deputy Registrar, and Assistant Deputy Registrar).

- 4—Section 5J of the Principal Act is amended as follows:—
 - (a) by inserting the following subsection after subsection (2):—
 - (2A) The Governor may appoint a person to be the Assistant Deputy Registrar of the Supreme Court.
 - (b) by omitting from subsection (3) "and (2)" and substituting", (2), and (2A)".

Amendment of section 5k of the Principal Act (Deputies acting in olace of Registrar).

- **5**—Section 5K of the Principal Act is amended as follows:—
 - (a) by omitting "a deputy Registrar" and substituting "the Deputy Registrar or the Assistant Deputy Registrar"; and
 - (b) by omitting "a Deputy Registrar" and substituting "the Deputy Registrar or the Assistant Deputy Registrar".

Amendment of section 5L of the Principal Act (Functions of Registrar in other offices).

6—Section 5L (1) of the Principal Act is amended by omitting "a Deputy Registrar" wherever occurring and substituting "the Deputy Registrar or the Assistant Deputy Registrar".

Amendment of section 10 of the Principal ((Act (Taxing officers).

7—Section 10 (1) of the Principal Act is amended by inserting the Assistant Deputy Registrar," after "the Deputy Registrar,".

Consequential amendment.

8—Section 2 of the Appeal Costs Fund Act 1968 is amended by omitting "Deputy Registrar;" from the definition of "Registrar" and substituting "Deputy Registrar and the Assistant Deputy Registrar;".
