AN ACT to amend the Stamp Duties Act 1931 to make further provision with respect to exemption from payment of stamp duty with respect to land in respect of which a home savings grant is payable.

[Royal Assent 4 November 1982]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the *Stamp Duties Amendment Act* Short title. 1982.

Commence-
ment.

2—This Act shall be deemed to have commenced on 2nd June 1982.

Principal Act.

3—In this Act, the *Stamp Duties Act 1931** is referred to as the Principal Act.

4—(1) Section 75A (1) of the Principal Act is amended as follows:—

- (a) by omitting “Commonwealth; or” from paragraph (a) in the definition of “full home savings grant” and substituting “Commonwealth;”;
- (b) by omitting from paragraph (b) in that definition “Commonwealth;” and substituting “Commonwealth; or”;
- (c) by inserting in that definition after paragraph (b) the following paragraph:—
 - (c) the appropriate maximum amount payable under section 39 (2), (3), or (4) of the *Home Deposit Assistance Act 1982* of the Commonwealth;

(2) Section 75A (1) of the Principal Act is further amended as follows:—

- (a) by omitting “Commonwealth; or” from paragraph (a) in the definition of “home savings grant” and substituting “Commonwealth;”;
- (b) by omitting from paragraph (b) in that definition “Commonwealth;” and substituting “Commonwealth; or”;
- (c) by inserting in that definition after paragraph (b) the following paragraph:—
 - (c) a grant made under section 17 of the *Home Deposit Assistance Act 1982* of the Commonwealth;
- (d) by omitting paragraph (b) in the definition of “person entitled” and substituting the following paragraph:—
 - (b) has been notified by an officer of a Department of the Commonwealth that he will receive,

(3) Section 75A of the Principal Act is amended by inserting after subsection (9) the following subsection:—

(10) This section does not apply to a person entitled to a home savings grant and eligible for a grant under the *First Home Assistance Act* 1982.
