**AN ACT to amend the Stamp Duties Act 1931 to provide for the payment of stamp duty on certain instruments.**

[Royal Assent 21 May 1980]

**BE** it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

**1**—This Act may be cited as the *Stamp Duties Amendment Act* Short title.  
 (No. 2) 1980.

**2**—(1) This section and section 1 shall commence on the date Commencement.  
 of assent to this Act.

(2) Except as provided in subsection (1), this Act shall commence on the date fixed by proclamation under section 2 (2) of the *Land Titles Act* 1980.

Principal Act.

**3**—In this Act, the *Stamp Duties Act 1931\** is referred to as the Principal Act.

Amendment of second Schedule.

**4**—The second Schedule to the Principal Act is amended as follows:—

(a) by inserting after item 15 the following item:—

15A	Declaration of severance of a joint tenancy under section 63 of the <i>Land Titles Act 1980</i>	\$3.00	By the person lodging the declaration.

(b) by inserting after item 19 the following items:—

19A	Instrument under section 88 of the <i>Land Titles Act 1980</i> increasing the amount secured under a mortgage or encumbrance .....	\$3.00 or ¼ of one per cent of the amount by which the amount secured is increased, whichever is the greater.	By the mortgagor or encumbrancer.
19B	Instrument under section 88 of the <i>Land Titles Act 1980</i> varying a mortgage or encumbrance (not being an instrument increasing the amount secured under the mortgage or encumbrance) .. ....	\$3.00	By the mortgagor or encumbrancer.

Amendment of third Schedule.

**5**—Part I of the third Schedule to the Principal Act is amended, with respect to the exemption operating in relation to item 9 in the second Schedule, by adding in the second column of that Part the words:—

Any certificate of title prepared following a rearrangement pursuant to section 33 (13) of the *Land Titles Act 1980* or prepared pursuant to section 33 (18) of that Act.
