STATE EMPLOYEES (LONG-SERVICE LEAVE) (No. 2).

AN ACT to amend the *State Employees (Long-Service Leave) Act 1950*. [14 December 1971.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as the *State Employees (Long-Service Leave) Act (No. 2) 1971*.

(2) The *State Employees (Long-Service Leave) Act 1950*, as subsequently amended, is in this Act referred to as the Principal Act.

2 Section six of the Principal Act is amended by adding at the end thereof the following subsection:—

“(5) A regulation prescribing an authority as an authority to which this section applies may contain a provision limiting its effect to—

(a) a specified class or group of persons employed by that authority; and

(b) a specified period of time or occasion.”.

1—(1) This Act may be cited as the *Retirement Benefits Act* 1971.

(2) The *Retirement Benefits Act* 1970 is in this Act referred to as the Principal Act.

2 Section forty-nine of the Principal Act is amended by inserting in subsection (2) thereof, after the word “contributor”, the words “or of a person who, at the time of his death, was still a contributor”.
