AN ACT to amend the Straits Islands Abattoirs Act [26 April 1956.] 1950.

RE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:---

- 1—(1) This Act may be cited as the Straits Islands Short title and citation. Abattoirs Act 1956.
- (2) The Straits Islands Abattoirs Act 1950, as subsequently amended, is in this Act referred to as the Principal Act.
- 2 Section eight of the Principal Act is amended by omit-Borrowing powers of the ting therefrom the numerals "£231,500" and substituting Treasurer. therefor the numerals "£246.500".
- 3 Section nine of the Principal Act is amended by omit-Advances to boards. ting subsection (2) and substituting therefor the following subsection:-
- "(2) The Treasurer may, out of the moneys borrowed under the authority of section eight, advance to a board such sum of money, not exceeding-
 - (a) in the case of the King Island Abattoirs Board, the sum of £25,000; or
 - (b) in the case of the Flinders Island Abattoirs Board, the sum of £10,000,

as the board may require for the purpose of meeting expenses of working or interest.".

- 4 Section eleven of the Principal Act is amended—
 - (a) by omitting from subsection (1) the words "Sub-profit and loss ject to this section," and by omitting from that subsection the numerals "1956" and substituting therefor the numerals "1957":

- (b) by omitting subsections (2) and (3) and substituting therefor the following subsections:—
 - "(2) In the financial year that commences on the first day of July 1958 and in each financial year thereafter the Treasurer may, out of any moneys voted by Parliament for that purpose, make grants to the King Island Abattoirs Board to enable it to defray all or any of the expenses of working incurred or to be incurred by it, or to pay any interest payable by it, under this Act.
 - "(3) The King Island Abattoirs Board shall, at such times as the Minister may direct, prepare and submit to the Minister, in such form and containing such particulars as the Minister may require, annual estimates of its receipts and expenditure under this Act."; and
