AN ACT to amend the Straits Islands Shipping Services Subsidies Act 1948.

[Royal Assent 28 November 1985]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the *Straits Islands Shipping Services Subsidies Amendment Act 1985*. Short title.

**2**—(1) This section and section 1 shall commence on the day on which this Act receives the Royal assent.

(2) Except as provided in subsection (1), this Act shall commence on such day as may be fixed by proclamation.

Principal Act.

**3**—In this Act, the *Straits Islands Shipping Services Subsidies Act 1948\** is referred to as the Principal Act.

**4**—Section 3 of the Principal Act is amended as follows:—

(a) by omitting from subsection (3) “ or subsection (4) ”;

(b) by omitting subsections (2) and (4).

**5**—Section 3A of the Principal Act is amended as follows:—

(a) by omitting from subsection (1) “ of the livestock or cargo specified in Schedule II ” and substituting “ live-stock or other cargo ”;

(b) by omitting subsection (4).

**6**—After section 3A of the Principal Act, the following section is inserted:—

Maximum rates  
of subsidy.

**3B**—(1) The subsidies payable under this Act shall be payable at such rates, not exceeding the rates respectively prescribed by order-in-council, as may be specified in the agreement.

(2) The Governor may, by order-in-council, prescribe the maximum rates of subsidies payable under this Act.

**7**—Schedules I and II to the Principal Act are repealed.

Power to make  
retrospective  
orders-in-  
council.

**8**—An order-in-council made under section 3B (2) of the Principal Act, as amended by this Act, may take effect on and from 1st July 1984 or any later date.
