STATUTE LAW REVISION (MISCELLANEOUS **AMENDMENTS) ACT 1992**

No. 36 of 1992

AN ACT to amend the Tsuneichi Fujii Fellowship Trust Act 1985 and to repeal the Agent-General Act 1911

[Royal Assent 10 December 1992]

B^E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

PART 1

PRELIMINARY

Short title

1-This Act may be cited as the Statute Law Revision (Miscellaneous Amendments) Act 1992.

Commencement

2—This Act commences on the day on which it receives the Royal Assent.

PART 2

AMENDMENT OF TSUNEICHI FUJII FELLOWSHIP TRUST ACT 1985*

Section 18 amended (Annual Report)

- 3—Section 18 of the Tsuneichi Fujii Fellowship Trust Act 1985 is amended as follows:—
 - (a) by omitting from subsection (1) "and submit the report to the Minister";
 - (b) by omitting subsection (3) and substituting the following subsections:—
 - (3) A report referred to in subsection (1) is to be appended to the annual report prepared by the Department pursuant to section 33AB (1) of the Tasmanian State Service Act 1984.
 - (4) Subsection (3) has effect notwithstanding section 33AB (2) of the *Tasmanian State Service Act 1984*.

Section 19 amended (Transitional)

4—Section 19 of the *Tsuneichi Fujii Fellowship Trust Act* 1985 is amended by omitting subsection (3).

PART 3

REPEAL OF AGENT-GENERAL ACT 1911†

Agent-General Act 1911 repealed

5—The Agent-General Act 1911 is repealed.
