STRAITS ISLANDS ABATTOIRS.

No. 13 of 1955.

AN ACT to amend the Straits Islands Abattoirs Act 1950. [27 May, 1955.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation.

- 1—(1) This Act may be cited as the Straits Islands Abattoirs Act 1955.
- (2) The Straits Islands Abattoirs Act 1950, as subsequently amended, is in this Act referred to as the Principal Act.

Power of Treasurer to borrow moneys. 2 Section eight of the Principal Act is amended by omitting the numerals "176,500" and substituting therefor the numerals "231,500".

Advances to boards.

3 Section nine of the Principal Act is amended by omitting from paragraph (a) of subsection (1A) the numerals "116.500" and substituting therefor the numerals "171,500".

SUNDAY OBSERVANCE.

No. 14 of 1955.

AN ACT to amend the Sunday Observance Act 1908. [6 June, 1955.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and citation.

- 1—(1) This Act may be cited as the Sunday Observance Act 1955.
- (2) The Sunday Observance Act 1908, as subsequently amended, is in this Act referred to as the Principal Act.

- 2 Section eleven of the Principal Act is amended—
- Works of necessity or mercy.
- (a) by omitting the proviso to paragraph XI;
- (b) by omitting paragraphs XII and XIII and substituting therefor the following paragraphs:—
 - "XII The baking, and the sale by wholesale," of bread:
 - "XIIA The sale, subject to the provisions of the Shops Act 1925, between the hours of nine o'clock in the forenoon and nine o'clock in the afternoon of goods of all or any of the kinds that are specified in the second schedule:
 - "XIII The opening in any city or municipality, between the hours of nine o'clock in the forenoon and ten o'clock in the afternoon, of restaurants, tea rooms, and tea gardens carried on in good faith for the proper purposes thereof, for the convenience of the public:";
- (c) by omitting paragraph XVIII and substituting therefor the following paragraph:—
 - "xviii Subject to subsection (2) of this section, any work that is declared by the Governor, by order, to be a work of necessity or mercy."; and
- (d) by adding at the end thereof the following subsection:—
 - "(2) If an order is made under paragraph XVIII of subsection (1) of this section on any day when either House of Parliament is sitting, the Minister shall cause copies of the order to be laid upon the table of each House of Parliament as soon as practicable after the order is made, and the order shall not take effect unless and until it is approved by a resolution of both Houses of Parliament, but in any other case the Minister shall cause copies of the order to be laid upon the table of each House of Parliament within the first seven sitting days of the House after the order is made, and thereupon the provisions of subsections (4) and (5) of section forty-seven of the Acts Interpretation Act 1931 shall apply to the order as if it were a regulation."
- 3 Section twelve of the Principal Act is amended by omit-Violation ting therefrom the word "ten" and substituting therefor of Act. the word "twenty".

Offence by employer.

4 Section thirteen of the Principal Act is amended by omitting therefrom the word "ten" and substituting therefor the word "twenty".

Offence by corporation.

5 Section fourteen of the Principal Act is amended by omitting therefrom the word "ten" and substituting therefor the word "twenty".

Limitation of actions.

6 Section fifteen of the Principal Act is repealed.

Schedules.

- 7 The Principal Act is amended—
 - (a) by inserting in the heading to the schedule thereto, after the word "The", the word "First"; and
 - (b) by adding at the end thereof the following schedule:---

"THE SECOND SCHEDULE.

(Section 11.)

"GOODS PERMITTED TO BE SOLD ON SUNDAY.

- 1. Bread, cakes, pastry, tarts, pies, and other goods of a like nature.
- 2. Confectionery and sweetmeats of every description.

3. Cooked meats.

- 4. Ice creams and ice blocks.
- 5. Milk drinks, soda fountain drinks, and other nonalcoholic drinks.
- 6. Fresh fruits and vegetables of all kinds.7. Fresh or cooked fish of every description (other than fish in tins or other sealed containers).
- 8. Potato chips.
- 9. Tobacco, cigars, cigarettes, and cigarette papers. 10. Milk and cream.".
