## AN ACT to amend the Sunday Observance Act 1968.

[Royal Assent 1 November 1985]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the Sunday Observance Amendment Short title. Act 1985.

2—This Act shall commence on the day on which the Racing and Commence-Gaming Amendment Act 1985 commences. Amendment of section 3 of Sunday Observance Act 1968 (Sunday work forbidden). **3**—Section 3 of the Sunday Observance Act 1968\* is amended by inserting the following subsections after subsection (2):—

(3) Notwithstanding subsection (1), a person may, on the Sunday immediately preceding the first Tuesday in November in any year, act as provided in paragraph (b), (c), or (d) of that subsection if—

- (a) he so acts, on a racecourse or elsewhere, for the purpose of, or in connection with, the conduct of totalizator betting on that racecourse under a totalizator licence in force under section 57u of the Racing and Gaming Act 1952;
- (b) on a racecourse in respect of which such a totalizator licence is in force, he so acts—
  - (i) for the purpose of carrying on business as

     a bookmaker under a certificate of
     registration in force under section 59
     of that Act or under a provisional
     certificate of registration in force under
     section 59A of that Act;
  - (ii) for the purpose of carrying on business on behalf of a bookmaker under a substitute certificate of registration in force under section 59 (8) of that Act;
  - (iii) as a bookmaker's clerk under a certificate of registration in force under section 59 of that Act;
  - (iv) as an officer or other employee of the club the committee of which holds that totalizator licence;
  - (v) as an officer of the Tasmanian Racing Directorate; or
  - (vi) in the course of his employment pursuant to section 11A (1) of the *Racing Act* 1983; or

(c) he so acts—

- (i) on a racecourse in respect of which such a totalizator licence is in force, or elsewhere, for the purpose of or in connection with, or incidental to or arising out of, the conduct of the race meeting, or a horse race or greyhound racing event, held on the racecourse pursuant to that licence; or
- (ii) on such a racecourse for the purpose of riding or driving in such a horse race or of providing a service or facility for persons attending that race meeting.

(4) Where in subsection (3) an expression that is defined in section 3 of the *Racing and Gaming Act* 1952 is used, that expression shall be so defined for the purposes of this section.

4—This Act shall expire on 30th November 1986, and after that Expiry of Act. date the Sunday Observance Act 1968 shall have effect as if this Act had never been enacted.
