STATE TEACHERS' SUPERANNUATION FUND.

No. 26 of 1948.

AN ACT to amend the State Teachers Super-annuation Fund Act 1904. [23 July, 1948.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

Short title and citation.

- **1**—(1) This Act may be cited as the State Teachers' Superannuation Fund Act 1948.
- (2) The State Teachers' Superannuation Fund Act 1904*, as subsequently amended, is in this Act referred to as the Principal Act.

Increase in rates of annuity.

- **2**—(1) Every annuity which is in force and payable at the first day of October, 1948, or for which any person is then eligible, shall thereafter be paid at a rate increased by one-fourth of the rate at which, but for this section, it would have been payable.
- (2) The Treasurer shall pay to the Fund all such amounts as may be necessary to give effect to the increases in the rates of annuity prescribed by this section.

SORELL RAILWAY STATION SITE VESTING.

No. 27 of 1948.

AN ACT to amend the Sorell Railway Station Site Vesting Act 1929. [23 July, 1948.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

Short title

1—(1) This Act may be cited as the Sorell Railway Station Site Vesting Act 1948.

- (2) The Sorell Railway Station Site Vesting Act 1929* is in this Act referred to as the Principal Act.
- 2 Section two of the Principal Act is amended by omitting Vesting subsection (2) and substituting therefor the following sub-described in the schedule.
- "(2) The Warden Councillors and Electors of the Municipality of Sorell may sell the land referred to in subsection (1) of this section and may use the proceeds of such sale for the provision of recreational facilities for the residents of the said municipality.".

LANDLORD AND TENANT (TEMPORARY PROVISIONS).

No. 28 of 1948.

AN ACT to make provision for the continuation for a limited period of the operation, in relation to this State, of the provisions of certain Commonwealth Regulations, and for matters incidental thereto.

[23 July, 1948.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1—(1) This Act may be cited as the Landlord and Tenant Short title and commencement.

 (Temporary Provisions) Act 1948.
- (2) This Act shall commence on a day to be fixed by proclamation (in this Act referred to as "the commencing day").
- (3) Any day fixed in pursuance of subsection (2) of this section may be a day either before or after the date of the proclamation fixing that day.
