AN ACT to amend the State Sinking Fund Act 1929, the Public Works Execution Act 1934, the Public Works Execution Act (No. 2) 1934 and the Public Works Execution Act 1935.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :--

1—(1) This Act may be cited as the State Sinking Fund short title and citation Act 1955. and citation.

(2) The State Sinking Fund Act 1929, as subsequently amended, is in this Act referred to as the Principal Act.

2 Section thirteen of the Principal Act is repealed and the following section is substituted therefor:---

"13.—(1) On the first day of July in each year, or as $\frac{Sinking}{fund for}$ soon thereafter as is practicable, the Commissioners-

(2) All moneys received by the Treasurer under this section shall be applied towards meeting the losses incurred by the State in connection with the settlement of returned soldiers under the Returned Soldiers' Settlement Act 1916 or the Closer Settlement Act 1929 or in connection with the settlement of settlers under the War Service Land Settlement Act 1950.".
