

AN ACT to provide for the Execution of certain Works in connection with the Provision by the State of Accommodation Houses for Tourists. [19 August, 1935.]

A.D. **1935.** 

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as the State Tourist Accommodation Short title. Houses Execution Act 1935.

### State Tourist Accommodation Houses Execution.

Power to Minister to cause works to be executed.

Power Treasurer to borrow £215 3s. 4d. and to re-

- 2 The Minister may cause the works specified in the first schedule to be undertaken and executed at a cost for each separate work not exceeding the amount specified in that schedule in respect thereof.
- 3 The Treasurer may, for the purpose of defraying the costs of the works authorised by this Act—
  - 1. Raise, borrow, and receive any sum or sums of money not exceeding in the whole the sum of two hundred and fifteen pounds three shillings and four pence: and
  - II. Reappropriate the sums specified in the second schedule, amounting in the aggregate to fifteen pounds sixteen shillings and eight pence.

## WORKS TO BE EXECUTED.

1. Additions and improvements to Rainbow Chalet at Tiagarra, including the provision of garage for three cars, with changing room attached; lining of walls of laundry and ceiling and walls of skillion at back of chalet; bricking-in of copper, and providing colonial oven in open fireplace of kitchen 100

2. Additional furniture for Miena Accommodation House 75

3. Amount required to recoup lessee of Lake Leake Accommodation House for provision of dairy, staff-room, and additional stove 56
