AN ACT to provide for the Execution of certain Works in connection with the Provision by the State of Accommodation Houses for Tourists.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as the State Tourist Accommodation Houses Execution Act 1936.

#### State Tourist Accommodation Houses Execution.

#### A.D. 1936.

Power to Minister to caus works to be executed.

Power to Treasurer to borrow £239 14s. 7d. and to reappropriate £70 5s. 5d.

- **2** The Minister may cause the works specified in the first schedule to be undertaken and executed at a cost for each separate work not exceeding the amount specified in that schedule in respect thereof.
- 3 The Treasurer may, for the purposes of defraying the costs of the works authorised by this Act—
  - 1. Raise, borrow, and receive any sum or sums of money not exceeding in the whole the sum of two hundred and thirty-nine pounds fourteen shillings and seven pence: and

11. Reappropriate the sums specified in the second schedule, amounting in the aggregate to seventy

pounds five shillings and five pence.
