

SHOP TRADING HOURS AMENDMENT ACT 1987

No. 113 of 1987

AN ACT to amend the Shop Trading Hours Act 1984.

[Royal Assent 23 December 1987]

B^E it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:-

- 1—This Act may be cited as the Shop Trading Hours Short title. Amendment Act 1987.
- 2—This Act shall commence on the day on which it receives Commencement. the Royal assent.
- 3—In this Act, the Shop Trading Hours Act 1984* is referred Principal Act. to as the Principal Act.

Insertion of new section 5A in Principal Act.

4—After section 5 of the Principal Act, the following section is inserted:—

Special provision with respect to certain shops located in certain areas

5A—(1) In this section—

"prescribed area" means—

- (a) the area in the city of Hobart bounded Street, Argyle Street, by Bathurst Macquarie Street, and Harrington Street; or
- (b) the area in the city of Launceston bounded by George Street, Cimitiere Street, Wellington Street, and York Street;
- "prescribed period" means the period commencing on 26th December 1987 and ending on 14th January 1988.
- (2) A shop which is located in a prescribed area and which, apart from this subsection, would be a shop to which section 5 applies may, notwithstanding the provisions of that section, be kept open at any time on a day during the prescribed period which would, apart from this subsection, be a day on which, or a day during part of which, that shop would be required to be closed.
- (3) Section 8 does not apply in relation to any work as an employee in a shop located in a prescribed area that is performed at any time on a day during the prescribed period.
