AN ACT to amend the *Transport Act* 1938. [28 *November*, 1939.]

A.D. 1939.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as the Transport Act 1939.

2 The Principal Act is hereby amended—

Section 9.

I. By inserting the words "(including payment of taxes levied in respect of motor vehicles)" after the word "obligations" in the third line of paragraph v. of subsection (1) of section nine thereof:

- II. By inserting at the end of section twelve thereof the following new subsections (3) and (4)—
 - "(3) The Railway Advances and Suspense Accounts Act 1923 is hereby incorporated, and shall be read as one with this Act.
 - (4) In the application of the Act last cited to this Part, any reference to the Commissioner for Railways or to Railway Department shall be construed as a reference to the Commission.":

III. By deleting the words "in respect of that financial year" in the penultimate line of subsection (4) of section nineteen thereof:

- IV. By expunging subsection (2) of section twenty thereof and substituting therefor the following new subsections (2) and (3)—
 - "(2) The Commission may at any time apply to the Treasurer for an advance for meeting expenses of working, depreciation, or interest, and the Treasurer may, in his discretion, advance to the Commission such amount as he shall think fit, upon such terms as to repayment thereof as the Treasurer shall determine.
 - (3) The amount which may be advanced by the Treasurer to the Commission for the purposes of subsection (2) hereof shall not at any time exceed two hundred and fifty thousand pounds, and the Treasurer may raise, borrow, and receive any sum of money not exceeding in the whole the sum of two hundred and fifty thousand pounds for the purposes of that subsection.":

 - v. A statement of the amount of revenue received pursuant to paragraph I. of subsection (2) of section nineteen and of the expenditure of revenue-

but the receipts mentioned in paragraph I. hereof shall not include receipts under paragraphs II. to v., VII., or VIII. of subsection (1) of section nineteen, and the trading account therein mentioned shall not include expenditure properly chargeable against the revenues of the Commission derived under those paragraphs.": and
