AN ACT to amend the Traffic Act 1925 to provide for the appointment of a deputy chairman to the Public Vehicles Licensing Appeal Tribunal, to extend the power to postpone the commencement of a period of disqualification of a driver's licence, to enable authorized officers of the Transport Commission to serve infringement notices, and to provide for incidental matters.

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the *Traffic Amendment Act* (No. 2) Short title. 1979.

Principal Act.

2—In this Act, the *Traffic Act* 1925* is referred to as the Principal Act.

Amendment of section 30A of Principal Act (Public Vehicles Appeal Tribunal).

- **3**—(1) Section 30A of the Principal Act is amended by omitting subsection (2) and substituting the following subsection:—
 - (2) The tribunal shall consist of—
 - (a) three members, appointed by the Governor, of whom—
 - (i) one shall be a magistrate, who shall be chairman of the tribunal; and
 - (ii) the others shall be persons nominated as provided in subsection (3); and
 - (b) three deputy members so appointed of whom-
 - (i) one shall be a magistrate, who shall be deputy chairman of the tribunal; and
 - (ii) the others shall be persons nominated as provided in subsection (3).
- (2) Section 30A (3) of the Principal Act is amended by omitting "subsection (2)" and substituting "subsection (2) (a) (ii) and (b) (ii)".
- (3) Section 30A of the Principal Act is further amended by omitting subsection (3B) and substituting the following subsections:—
 - (3B) Whenever the chairman of the tribunal—
 - (a) is by reason of illness or for any other reason unable to carry out his duties with respect to the hearing and determination of an appeal under section 30B; or
 - (b) directs the deputy chairman of the tribunal to carry out those duties in his place,

the deputy chairman of the tribunal shall carry out those duties and, while so doing, shall be deemed to be the chairman of the tribunal for the purposes of, and in connection with, the hearing and determination of that appeal.

- (3c) The deputy chairman of the tribunal shall not act as a member of the tribunal except as provided in subsection (3B), and a deputy member, other than the deputy chairman of the tribunal, shall not act as a member of the tribunal unless directed to do so by the chairman of the tribunal or, where the deputy chairman of the tribunal is acting in place of the chairman, by the deputy chairman.
- (4) Section 30A (5) of the Principal Act is amended by inserting "and deputy chairman" after "chairman".
- 4—(1) Section 35 (1) of the Principal Act is amended by Amendment of Section 35 of Principal Act omitting "under this Act". (Commencement of period
- (2) Section 35 (2) of the Principal Act is amended by omitting of disqualification. "under this Act".
- 5—Section 43H (1) of the Principal Act is amended by inserting Amendment of "or an authorized officer" after "police officer".
