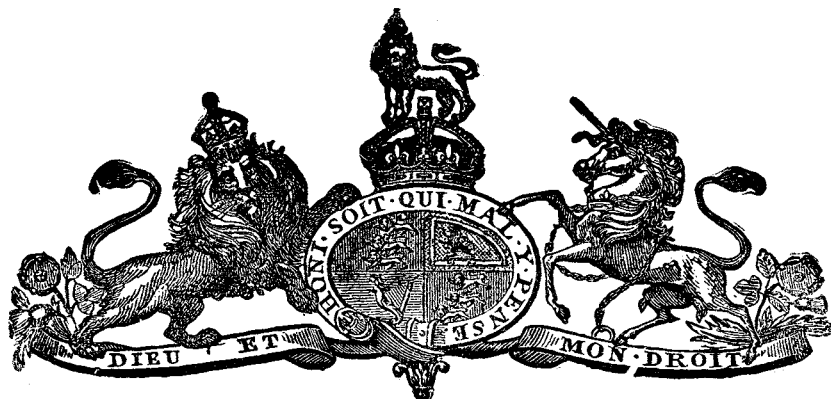

ANALYSIS.

1. Short title and incorporation with 2 Geo. V. No. 64.
2. Certain persons whose lands have been forfeited may be reinstated as purchasers.
3. Certain persons named in Schedule (2) to be permitted to complete their purchases.
4. Power to Commissioner to sell land to *Percy Chilcott*.

AN ACT to provide for the Reinstatement of certain Persons as Purchasers of certain Crown Lands, and to authorise the Governor to convey and alienate certain pieces of Land. A.D. 1932.
[23 December, 1932.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—(1) This Act may be cited as “The Crown Lands Purchasers Reinstatement Act, 1932.”

Short title and incorporation with 2 Geo. V. No. 64.

(2) This Act shall be incorporated with the Crown Lands Act, 1911, in this Act referred to as the Principal Act.

Crown Lands Purchasers Reinstatement.

A.D. 1932.

Certain persons whose lands have been forfeited may be reinstated as purchasers. Schedule (1).

2 The Commissioner, with the consent of the Governor, may reinstate the persons named in Schedule (1) as purchasers of the several lots or areas of land set opposite to their names respectively, under the provisions of the Acts regulating the sale or disposition of Crown Lands under which the purchases of those lots or areas were made respectively; and thereupon such persons shall be liable to pay all instalments due upon such lands at the date of forfeiture and all instalments thereafter due thereon, together with the amount of fines and charges for the cost of advertising, as provided by Section Ninety-six of the Principal Act, together with interest at the rate of Five Pounds per centum per annum from the dates when such instalments became due respectively.

Certain persons named in Schedule (2) to be permitted to complete their purchases.

3 The Commissioner may permit the persons named in Schedule (2) to complete the purchase of the several areas of land set opposite to their names; and upon payment of the balance of purchase-money into the Treasury, together with a grant fee of Twenty Shillings, the Governor may, in the name and on behalf of His Majesty, convey and alienate such lands in fee simple to those persons respectively.

Power to Commissioner to sell land to *Percy Chilcott*. Schedule (3).

4 The Commissioner may accept the moneys paid by *Percy Chilcott* in respect of the purchase of certain land in the Town of Nietta, containing seventy-seven acres two roods and thirty-three perches, as payment of the purchase price of the land described in Schedule (3), being portion of the said land containing seventy-seven acres two roods and thirty-three perches, and the Governor may, in the name and on behalf of His Majesty, convey and alienate the said land described in Schedule (3) to the said *Percy Chilcott* in fee simple.

TOWN OF NIETTA.

LOT 2, SECTION C (67 ACRES).

Bounded on the north by 21 chains 19 links easterly along Lot 3 purchased by C. V. Stanley and along Crown land commencing at the south-west angle of that lot on the east by 7 chains 32 links southerly along Lot 2A again on the north by 13 chains 31 links easterly also along that lot on the south-east by 17 chains 21 links south-westerly along a reserved road on the south by 28 chains 32 links westerly along land purchased by J. Luck and thence on the west by 24 chains 2 links northerly also along that land along a reserved road and along land purchased by E. Crawford to the point of commencement.
