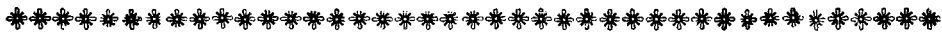

AN ACT to further amend "The Codlin A.D. 1900.
Moth Act, 1888." [18 October, 1900.] 52 Vict. No. 16.

BE it enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

1 This Act may be cited as "The Codlin Moth Amendment Act, Short title. 1900."

2 The Board of every district shall, in and by the notice of the time and place fixed for the Annual Meeting of Fruitgrowers, appoint a day for the reception of nominations as hereinafter mentioned, not less than Five days nor more than Ten days before the day fixed for such Annual Meeting, and the Chairman of the Board shall, during the Three days immediately preceding the day so appointed, and up to Four of the clock in the afternoon of such day, receive nominations of persons qualified to be elected as members for election at such Annual Meeting. Nomination of candidates for election.

3 The Board of every such district shall cause a list of the candidates nominated for election to be published in at least Two consecutive numbers of a public newspaper published in *Hobart* or *Launceston* or in a town in or nearest to the Fruit District in which the Annual Meeting of Fruitgrowers is to be held ; and shall also cause such list to be posted up in the Office of the Board and at every Police Office, Police Station, and Post Office in the district not less List of candidates to be published.

than Three clear days before the day fixed for such Annual Meeting, and none but persons so nominated shall be capable of being elected.

Form of nomination. Schedule.

4 Every nomination of a candidate for election as a Member of the Fruit Board of any district shall be in writing, in the form in the Schedule, or to the like effect, and shall be signed by at least Two fruitgrowers entitled to vote at such election, and no such nomination shall contain the names of more candidates than the number of Members to be elected. And with such nominations there shall be delivered to the Chairman a consent in writing signed by the candidate or candidates so nominated declaring his or their consent to be so nominated; and the Chairman shall not recognise any nomination of any candidate in the absence of such consent; and every such nomination and consent may be in writing, or partly written and partly printed.

Election of Members.

5 The Chairman of every meeting for the election of Members of a Fruit Board shall fix a time for commencing and closing the poll, if any, for such election; and every such poll shall remain open for Two hours at least; and every such election of Members shall be finished in One day without any adjournment whatsoever.

Repeal.

6 Section Twenty-one of "The Codlin Moth Act, 1888," is hereby repealed.

7 This Act and "The Codlin Moth Act, 1888," and every Act amending the same, shall be read and construed together as one and the same Act.
