AN ACT to amend the Cressy Water Act, 1931. [8 December, 1931.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

This Act may be cited as "The Cressy Water Act, 1931," Short title,

Limitation of hours for garden watering.

2 The Cressy Water Act, 1894, is hereby amended—

- I. By inserting the figure "(1)" before the word "The" at the beginning of Section Fifty-six thereof and by adding at the end of that section the following new Subsection (2):—
 - "(2) For the purposes of this Act the expression 'domestic purposes' shall mean the use of water on the premises of any dwelling-house by the owner or occupier thereof and his family, servants, and workmen for the purposes of drinking, cooking, personal ablution, including baths; flushing urinals and water closets; washing and cleansing such dwelling-house and all articles used therein for personal use or in connection with housekeeping; and for washing and cleansing any yard, outhouse, stable, garage, or other outbuilding used in connection therewith, or any motor-car other than a motor-car used in connection with any trade or business or which is washed or cleansed in the course of any trade or business.":
- II. By repealing Section Fifty-eight thereof and substituting therefor the following new Section Fifty-eight:—
 - "58—(1) The trustees, if they think fit, may furnish to any person a supply of water for any purpose other than domestic purposes.
 - (2) Any such supply may be furnished at such charges and upon such terms and conditions as may be prescribed, or, where the same are not prescribed, as the trustees and the person to whom the supply is furnished may agree.
 - (3) As far as practicable, the supply of water, as provided by this section, shall be at uniform rates in all cases where the conditions are alike.":
- III. By deleting the words "a dwelling-house on" in the sixth line of Section Sixty-two thereof and substituting therefor the words "the outer boundary of": and
- IV. By inserting after Section Eighty-seven thereof the following new Section 87a:—
 - "87a—(1) The trustees, at any time, by resolution, may limit the hours during which water may be used for garden purposes, either generally or in respect of any specified part of the water district, and may fix different hours for different parts thereof, and either generally or for specified

periods or parts of the year, but so that an equal A.D. 1981. number of hours shall be allowed for such purpose in every part of such district.

- (2) Every such resolution shall be published twice in a newspaper circulating in the Water District, and, upon the expiration of seven days after the second of such publications, the same shall have the effect of a by-law, and any person using water in contravention thereof shall be liable to a penalty of Five Pounds.
- (3) The Governor, by proclamation, at any time may revoke or vary any such resolution, and thereupon the same shall cease to have effect, or shall have effect as so varied, as the case may be."
