SCHEDULE 2
ACTS REPEALED

AN ACT to amend the Tasmanian Development Act 1983 and to repeal the Primary Producers' Relief Act 1968.

[Royal Assent 10 November 1988]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1—This Act may be cited as the *Tasmanian Development Amendment Act 1988*. Short title.

Commencement. **2**—This Act shall commence on the day on which it receives the Royal assent.

Principal Act. **3**—In this Act, the *Tasmanian Development Act 1983** is referred to as the Principal Act.

Amendment of section 8 of the Principal Act (Functions of Authority). **4**—Section 8 (*f*) (i) of the Principal Act is amended by omitting “an” and substituting “a bushfire, drought, earthquake, flood, tempest, or other”.

Amendment of section 22 of Principal Act (Capital expenditure of Authority). **5**—Section 22 of the Principal Act is amended by omitting subsection (3) and substituting the following subsection:—

(3) Where the Authority receives an amount by way of repayment of a loan made from money appropriated by Parliament for the purpose, the Authority shall repay that amount to the Consolidated Fund in accordance with any directions given by the Treasurer.

Amendment of section 24 of Principal Act (Authority's power to borrow). **6**—Section 24 (1) of the Principal Act is amended by omitting “the *Closer Settlement Act 1957*, or the *Primary Producers' Relief Act 1968*” and substituting “or the *Closer Settlement Act 1957*”.

Miscellaneous amendments of Principal Act. **7**—Each provision of the Principal Act specified in column 1 of Schedule 1 is amended in the manner specified opposite the reference to that provision in column 2 of that Schedule.

Repeal of *Primary Producers' Relief Act 1968*, &c. **8**—The Acts specified in Schedule 2 are repealed.
