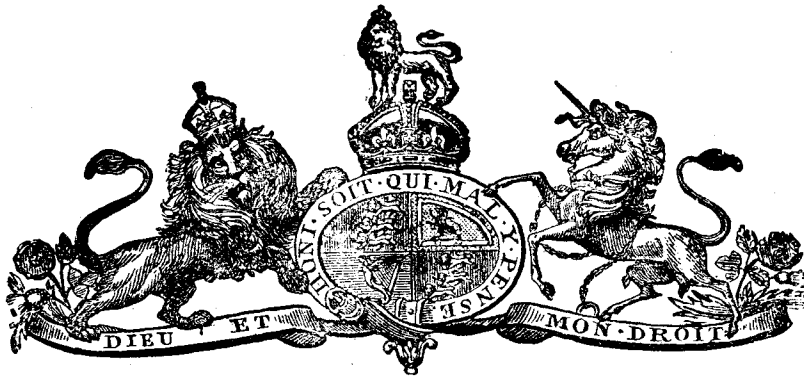

AN ACT to promote the Earlier Use of <sup>A.D.</sup> 1916. Daylight in certain Months yearly, and for other purposes relating thereto.

[22 September, 1916.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as "The Daylight Saving Act, 1916," and shall come into operation on a day to be fixed by proclamation. Short title and commencement.

**2** In this Act unless inconsistent with the context or subject matter—

"Standard time" means the mean time of the One hundred and fiftieth meridian of longitude east of Greenwich in England declared by "The Standard Time Act, 1895," to be standard time throughout Tasmania :

"Tasmanian clock time" means the time to be observed throughout Tasmania as prescribed by this Act.

**3**—(1) Notwithstanding anything contained in "The Standard Time Act, 1895," from the hour of Two in the morning of the First Sunday in October in each year until the hour of Two in the morning of the last Sunday in March in the next following year, "Tasmanian clock time" shall throughout Tasmania be One hour in advance of standard time.

(2) In this Section the expression, "the hour of Two in the morning" means that hour as determined by standard time.

**4** Notwithstanding anything contained in "The Standard Time Act, 1895," whenever any expression of time occurs in any Act, Order-in-Council, rule, regulation, by-law, contract (written or verbal), or deed, or in any instrument whatsoever, and whenever the doing or not doing anything at a certain time of day or night, or during a certain part of the day or the night has an effect in law, such time, with respect to any period during which Tasmanian clock time is declared by this Act to be in advance of standard time shall (unless it is otherwise specifically stated) be held to be Tasmanian clock time throughout Tasmania.

**5** Save as otherwise expressly provided in this Act the provisions of "The Standard Time Act, 1895," shall not be affected by this Act.

**6** Standard time as used for the purposes of astronomy and navigation shall not be affected by this Act.
