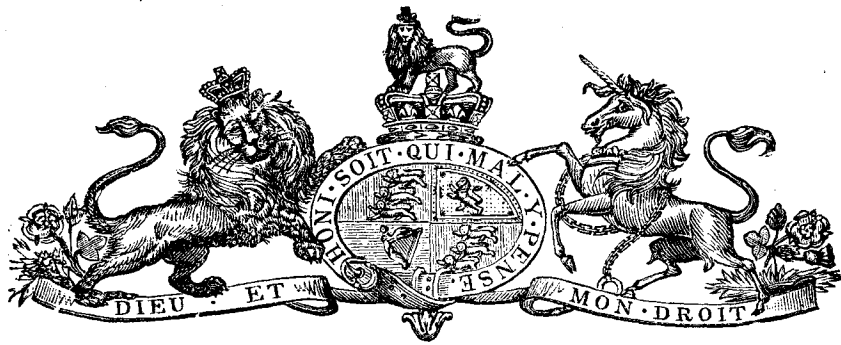

AN ACT to amend "The Electoral Act, A.D. 1898. 1896." *Repealed by 4 Ed: No 68*

[Reserved, 29 October, 1898 ; Royal Assent proclaimed, 3 February, 1899.]

BE it enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1 This Act may be cited as "The Electoral Amendment Act, 1898." Short title.
- 2 In this Act the expression "the said Act" shall mean "The Interpretation Electoral Act, 1896."
- 3—(1.) The words "*Gordon*..... One Member" are hereby inserted in the Schedule (2.) of the said Act after the words "*Pembroke*..... One Member" as a "Southern Council District," and the said Schedule (2.) shall hereafter be read and construed as if the words had been originally part of the said Schedule (2.).
- (2.) The words "*Montagu*..... One Member" in the Schedule (2.) of the said Act are hereby repealed, and the words—
 - "*Zeehan*..... One Member,
 - "*Lyell* One Member"
 are hereby inserted in lieu thereof as "Southern Assembly Districts," and the said Schedule (2.) shall hereafter be read and construed as if such last-mentioned words had originally been part of such Schedule (2.).

4 The description of the Council Electoral District of *Derwent* as set forth in the Schedule (3.) of the said Act is hereby repealed, and the descriptions of the Electoral Districts of *Derwent* and *Gordon* as set forth in Schedule (1.) to this Act are hereby enacted in lieu thereof, and the Electoral Districts of *Derwent* and *Gordon* as specified and described in the Schedule (1.) shall be and be deemed to be and may be cited as Southern Council Electoral Districts under the said Act, and shall hereafter be read and construed as part of Schedule (3.) of the said Act.

5 The description of the Assembly Electoral District of *Montagu* as set forth in the Schedule (3.) of the said Act is hereby repealed, and the descriptions of the Electoral Districts of *Zeehan* and *Lyell* as set forth in Schedule (1.) to this Act are hereby enacted in lieu thereof, and the Electoral Districts of *Zeehan* and *Lyell* as specified and described in the Schedule (1.) shall be and be deemed to be and may be cited as Southern Assembly Electoral Districts under the said Act, and shall hereafter be read and construed as part of Schedule (3.) of the said Act.

6 The Polling-places specified in Schedule (4.) of the said Act as Polling-places of the Council District of *Derwent* are hereby repealed, and the Polling-places specified in Schedule (2.) of this Act shall be the Polling-places for the Council Electoral Districts of *Derwent* and *Gordon*, and the last-mentioned Schedule shall be deemed to be and may be cited as part of Schedule (4.) of the said Act.

7 The Polling-places specified in Schedule (4.) of the said Act as Polling-places of the Assembly District of *Montagu* are hereby repealed, and the Polling-places specified in Schedule (2.) of this Act shall be the Polling-places for the Assembly Electoral Districts of *Zeehan* and *Lyell*, and the last-mentioned Schedule shall be deemed to be and may be cited as part of Schedule (4.) of the said Act.

Returning Officer

8—(1.) Upon the Royal Assent to this Act being proclaimed in *Tasmania*, the Returning Officer for the Electoral District of *Derwent* shall, within One month after such assent has been proclaimed, make out Two Electoral Rolls by dividing the existing Electoral Roll for the said District of *Derwent* into Two Electoral Rolls, and in one of such Rolls he shall place the names of all the Electors upon such first-mentioned Electoral Roll whose names have been placed upon such Roll as being resident in or owning or occupying property in the Electoral District of *Derwent* as defined by this Act, and in the other of such Rolls he shall place the names of all the Electors upon such first-mentioned Electoral Roll whose names have been placed upon such Roll as being resident in or owning or occupying property in the Electoral District of *Gordon* as defined by this Act.

Polling List to be

(2.) The Returning Officer shall at the same time prepare Polling Lists for the Electoral Districts of *Derwent* and *Gordon* according to the Polling-places set forth in the Schedule (2.) to this Act, in the same manner as the Court of Revision is directed to prepare Polling Lists under the provisions of "The Electoral Act, 1896."

9—(1.) Upon the Royal Assent to this Act being proclaimed in *Tasmania*, the Returning Officer for the Electoral District of *Montagu* shall, within One month after such assent has been proclaimed, make

out Two Electoral Rolls by dividing the existing Electoral Roll for the said District of *Montagu* into Two Electoral Rolls, and in one of such Rolls he shall place the names of all the Electors upon such first-mentioned Electoral Roll whose names have been placed upon such Roll as being resident in or owning or occupying property in the Electoral District of *Zeehan* as defined by this Act, and in the other of such Rolls he shall place the names of all the Electors upon such first-mentioned Electoral Roll whose names have been placed upon such Roll as being resident in or owning or occupying property in the Electoral District of *Lyell* as defined by this Act.

(2.) The Returning Officer shall at the same time prepare Polling Lists for the Electoral Districts of *Zeehan* and *Lyell* according to the Polling-places set forth in the Schedule (2.) to this Act, in the same manner as the Court of Revision is directed to prepare Polling Lists under the provisions of "The Electoral Act, 1896."

Polling Lists to be prepared.

10 When the Returning Officer has prepared the Electoral Rolls and Polling Lists as are mentioned in the last two preceding Sections, he shall sign the same and forward them to the Clerk of the Peace at *Hobart*, who shall forthwith deal with them in the manner prescribed by "The Electoral Act, 1896."

Electoral Rolls and Polling Lists to be forwarded to Clerk of the Peace.

11 Such Electoral Rolls and Polling Lists shall upon receipt thereof by the Clerk of the Peace, signed by the Returning Officer as aforesaid, be deemed to be the Electoral Rolls and Polling Lists for the respective Districts of *Derwent*, *Gordon*, *Zeehan*, and *Lyell*, and the persons whose names are inserted in such Electoral Rolls shall be the persons who are entitled to vote at any Election of a Member for any of such Electoral Districts, as the case may be, which may take place with respect to such Electoral Districts between the day upon which such Electoral Rolls are received by the Clerk of the Peace as aforesaid and the Eleventh day of *April*, One thousand eight hundred and ninety-nine.

Rolls as prepared to be Electoral Rolls for new Districts.

12 Every Registrar of Births and Deaths shall, for the purposes of Section Twenty-nine of the said Act, on or before the Seventh day of *December* in every year, make out and deliver to the Returning Officer of the Assembly District which includes any portion of the district for which such Registrar is appointed, a list of every male person over the age of Twenty-one whose death has been registered in such last-mentioned district during the Twelve months preceding the Twenty-fourth day of *November* in every year.

Registrars to furnish list of deaths registered in each year.

13 The said Act and this Act shall remain and continue in full force and operation until the Thirtieth day of *September*, One thousand eight hundred and ninety-nine.

The said Act continued.

14 The said Act as amended by this Act and this Act shall be read and construed together as one and the same Act.

Descriptions of Council Electoral Districts.

DERWENT.

Comprises the Assembly Districts of Cumberland and New Norfolk.

GORDON.

Comprises the Assembly Districts of Zeehan and Lyell as hereinafter described.

Descriptions of Assembly Electoral Districts.

ZEEHAN.

Bounded by the sea from the Pieman River to the Henty River, by that river to its source, thence by the southern shores of Lake Westwood and Lake Selina to a rivulet, by that rivulet to Anthony's Creek, by that creek to the Murchison River, by that river to the Mackintosh River, by that river to the Pieman River aforesaid, and thence by that river to the point of commencement.

LYELL.

Commencing at the junction of the Henty River with the sea and bounded by that river to its source, thence by the southern shores of Lake Westwood and Lake Selina to a rivulet, by that rivulet to Anthony's Creek, by that creek to the Murchison River, by that river to the Canning River, by that river to Lake Augusta, thence by a south-westerly line to the Collingwood River, by that river to the Franklin River, by that river to the Gordon River, by that river to the Sprent River, by that river to its source, thence by a line to the source of the Mainwaring River, by that river to the sea aforesaid, and thence by the sea to the point of commencement.
