AN ACT to further amend "The Evandale 1913. Water Act, 1894." [5 December, 1913.]

WHEREAS the trustees of the Evandale Water District find it Preamble. necessary to borrow a sum of money, not exceeding Four hundred Pounds, for the purpose of defraying the cost of purchasing and laying down a new column of pipes in order to make better provision for the supply of water to the town of Evandale, and the said trustees are desirous of obtaining the said money under the provisions of "The Local Public Works Loans Act, 1890":

And whereas a poll of the owners and occupiers of properties within the Evandale Water District was taken (after due notice thereof, by advertisement in the "Gazette" and daily newspapers), on the Twentyfifth day of March, One thousand nine hundred and thirteen, for the

purpose of deciding whether the said trustees should proceed with the said work, and the question was decided in the affirmative, the votes being recorded as follows:—Thirty-five in favour and One against:

And whereas the said poll is sufficient for the purposes of this Act: Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and incorporation with 58 Vict. No. 33.

1 This Act may be cited as "The Evandale Water Act, 1913," and shall be incorporated and read as one with "The Evandale Water Act, 1894," and every amendment thereof.

Power to borrow.

2 It shall be lawful for the trustees of the Evandale Water District, hereinafter referred to as the said trustees, to borrow any sum or sums of money not exceeding in the whole Four hundred Pounds, for the purpose of defraying the cost of purchasing and laying down a new column of pipes between the turbine and No. 1 Reservoir, in order to provide the town of Evandale with a sufficient supply of water.

Power to lend.

3 It shall be lawful for the Governor to grant in accordance with the provisions of "The Local Public Works Loans Act, 1890," and its amendments, any sum or sums of money not exceeding in the whole the sum of Four hundred Pounds, as a loan or loans to the said trustees, upon the security of all its revenue for the purpose aforesaid; and any such sum or sums of money shall be defrayed out of moneys to be provided by Parliament for that purpose.

Proviso.

Provided that it shall not be necessary to lay before either House of Parliament plans and specifications of the proposed work, nor the report of the Engineer-in-Chief thereon as provided in Section Two of "The Local Public Works Loans Act, 1890," but before any part of the said sum of Four hundred Pounds shall be advanced, plans and specifications of the proposed work, together with a report by the Engineer-in-Chief upon probable cost of such work, the sufficiency of the plans and specifications, and upon such other matter connected with the work as the Engineer-in-Chief may deem it desirable to refer to in the said report, and that the work can in his opinion be completed for the amount proposed to be borrowed, shall be submitted to and approved by the Governor.
