

AN ACT to provide for the Application of the Moneys granted by the Commonwealth to this State for the purpose of Affording Relief to Fruit Growers.

WHEREAS by the *Fruit Growers' Relief Act* 1933 of the Commonwealth it is enacted *inter alia* that the sum of Sixty-three thousand eight hundred Pounds shall be granted by the Commonwealth by way of financial assistance to this State, and that that sum shall be so granted upon condition that it is applied by the State for the benefit and assistance of necessitous fruit growers who satisfy an authority, nominated in that behalf by the State, that they have suffered losses in the export from Australia of apples or pears grown by them during the 1932-1933 season :

Preamble.

Fruit Growers' Relief.

- A.D. 1933. — Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—
- Short title. **1** This Act may be cited as “The Fruit Growers' Relief Act, 1933.”
- Interpretation. **2** In this Act—
 “Fruit growers” means growers of apples and pears :
 “The Board” means the Board of Management of the Agricultural Bank, constituted under the provisions of the State Advances Act, 1907 :
 7 Ed.VII. No. 20. “The Commonwealth Act” means the *Fruit Growers' Relief Act 1933* of the Commonwealth :
 “The Suspense Account” means the account kept pursuant to Section Three.
- Fruit Growers' Relief Suspense Account. **3**—(1) Upon the commencement of this Act, there shall be opened and kept in the books of the Treasury an account to be called “The Fruit Growers' Relief Suspense Account.”
 (2) There shall be paid and credited to the Suspense Account all moneys received by this State under the provisions of the Commonwealth Act.
- Application of moneys. **4** The amount standing to the credit of the Suspense Account shall be paid and applied by the Treasurer, as may be prescribed, upon the recommendation of the Board, for the benefit and assistance of fruit growers who satisfy the Board, in accordance with the regulations, that they have suffered losses in the export of apples and pears grown by them during the 1932-33 season, and that they are in necessitous circumstances.
- Authority. **5** For the purposes of Section Four of the Commonwealth Act, the Board shall be the authority nominated by this State.
- Regulations. **6** The Governor may make regulations for the purposes of this Act.
