W HEREAS it is desirable to amend "The Formby Water Act, PREAMBLE. 1889 ":

Be it therefore enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :-

Short title.

1 This Act may be cited for all purposes as "The Formby Water Amendment Act, 1907."

"Elector" means and includes every person, whether male or female, of or above the age of Twenty-one years, whose name is on the Assessment Roll as the owner or occupier of any property situate within the Town of *Devonport*:

Interpretation.

2 In this Act—

Notice of poll.

3 Notwithstanding anything to the contrary contained in the said Act, or any Amendment thereof, it shall be lawful for the Board of the Town of *Devonport* to borrow any sum or sums of money, not exceeding in the whole Four thousand Pounds, in addition to the sums of Twenty thousand Pounds and Five thousand Pounds already borrowed or authorised to be borrowed, for the purpose of carrying out the objects of the said Act and its amendments.

"The said Act" means "The Formby Water Act, 1889."

4 It shall be lawful for the Governor to grant, in accordance with the provisions of "The Local Public Works Loans Act, 1890," subject to the provisions of this Act, any sum or sums of money, not exceeding the sum of Four thousand Pounds, as an additional loan to the said Board of the Town of *Devonport*, for the purpose of carrying out the objects of the said Act and its Amendments; and such sum or sums shall be defrayed out of moneys to be provided by Parliament for the purpose.

5 The Board shall not proceed in the matter of borrowing any sum of money under the authority of this Act until and after a poll has been taken of the electors for the purpose of ascertaining whether the Board may borrow such moneys. If at the taking of such poll a majority of the votes then recorded shall be in favour of the Board borrowing any sum of money under this Act, the Board may borrow such money.

6 At such poll every elector shall have a number of votes proportioned to the annual value (as ascertained by the Assessment Roll in force for the time being) of the property within the Town of *Devonport* owned or occupied by him according to the scale set forth in Section Forty-five of "The Local Government Act, 1906," and the proceedings at the taking of the poll shall, with any necessary changes, be the same as those prescribed by law at an election of councillors. The ballotpapers to be used in the taking of such poll shall be in the form set forth in the Schedule to this Act.

7 When the said Board shall have decided to take a poll as aforesaid, it shall cause an advertisement of such poll to be inserted once in the *Gazette* and not less than Three times in a daily newspaper circulating in the Town of *Devonport*; and such advertisement shall contain the following particulars :--
