

AN ACT to amend "The King Island Marine Board Loan Act, 1916," and for other pur- $[24 \ December, \ 1919.]$ poses.

A.D. 1919.

W HEREAS the Marine Board of King Island was empowered by PREAMBLE. "The King Island Marine Board Loan Act, 1916," to borrow sums 7 Geo. V. No. 23 of money not exceeding One thousand five hundred Pounds for the purposes therein mentioned, to be repaid as therein mentioned:

And whereas the said Board has borrowed from the Governor under the said Act the sum of Eight hundred and ten Pounds, and has repaid the sum of One hundred and sixty-two Pounds on account thereof leaving a balance of Six hundred and forty-eight Pounds still owing by the said Board;

And whereas the said Board no longer requires to borrow the ballance of the said sum of One thousand five hundred Pounds still unborrowed, namely, the sum of Six hundred and ninety Pounds:

And whereas it is expedient to substitute other provisions for the provisions of Section Seven of the said Act with respect to the repayment of the moneys already borrowed under the said Act:

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and incorporation with 7 Geo. V. No. 23,

1 This Act may be cited as "The King Island Marine Board Loan Act, 1919," and shall be incorporated and read as one with "The King Island Marine Board Loan Act, 1916," hereinafter referred to as "the Principal Act."

Amendment of Section 3 of Principal Act. 2 Section Three of the Principal Act is hereby amended by omitting therefrom the words "One thousand five hundred Pounds," and substituting therefor the words "Eight hundred and ten Pounds."

Amendment of Section 5 of Principal Act, 3 Section Five of the Principal Act is hereby amended by omitting therefrom the words "One thousand five hundred Pounds," and substituting therefor the words "Eight hundred and ten Pounds."

Amendment of Section 7 of Principal Act by substituting fresh provisions for repayment of money borrowed. 4 In lieu of the provisions contained in Section Seven of the Principal Act for the repayment of the moneys borrowed thereunder, the Marine Board of King Island shall pay to the Treasurer the sum of Six hundred and forty-eight Pounds, being the balance of the moneys borrowed and not yet repaid, by the following instalments, namely:—By an instalment of Forty-eight Pounds, to be paid on the Thirty-first day of December, One thousand nine hundred and nineteen, and by Six instalments of One hundred Pounds each, to be paid on the Thirty-first day of December in each of the Six succeeding years.
