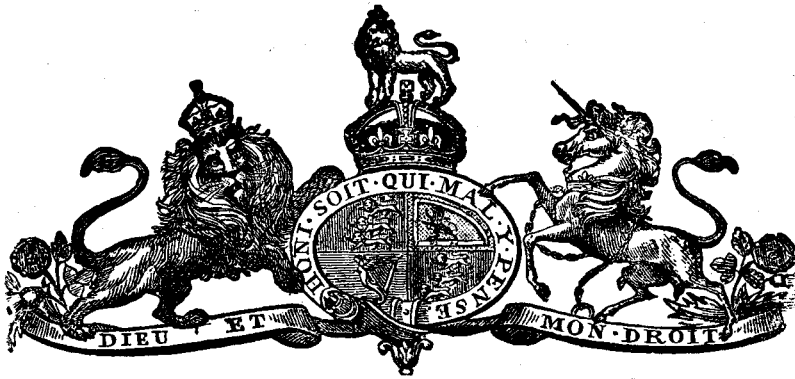

BE it enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows (that is to say) :—

3 It shall be deemed to have been lawful for any local governing body mentioned in the Schedule hereto to expend out of its funds the sum or sums opposite the name of such local governing body in the Schedule for the purpose or purposes mentioned in the Schedule, and such expenditure is hereby declared legal.
