

## AN ACT to further amend the Launceston Corporation Act, 1894. [17 September, 1928.]

A.D. **1928.** 

WHEREAS it is expedient to further amend the Launceston Preamble. Corporation Act, 1894, and make other provision for the enlargement of the City of Launceston:

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1 This Act may be cited as "The Launceston Corporation Act, Short title. 1928."
  - 2 In this Act, unless the context otherwise indicates—

    "The 1924 Act" means the Launceston Corporation Act 15 Geo. V. No. (No. 3), 1924:

"The City" means the City of Launceston.

3 Notwithstanding anything contained in Part IX. of the 1924 15 Geo. V. No. Act, from and after the thirtieth day of June, one thousand nine 59. hundred and twenty-eight, there shall be included within the bound-

aries of the City—All that piece of land situate in the Parish of Launceston, County of Cornwall, in Tasmania, bounded as follows, that is to say: On the north-west by four chains eighty-three links or thereabouts north-easterly along the north-western side of Hobbler's Bridge Road (the present boundary of the City) commencing at Patterson's Plains Road here now called Elphin Road and extending to the southwestern boundary of a location to Alexander Riley thence on the north-east south-easterly crossing half of Hobbler's Bridge Road thence again on the north-west nearly six chains north-easterly to a point opposite the north-eastern boundary of certain thirteen acres one rood and seven perches of land conveyed by the trustees of the will of the late Ronald Campbell Gunn to Elphin Property Limited (which thirteen acres one rood and seven perches is part of fifty-seven acres two roods nine perches granted to the said Ronald Campbell Gunn) thence again on the north-east south-easterly crossing half of Hobbler's Bridge Road to the northern corner of the said thirteen acres one road seven perches thence again on the north-east by eleven chains nineteen links and seven-tenths of a link south-easterly along other part of the said fifty-seven acres two roods nine perches sold to William James Little thence on the south-east by thirteen chains thirty links and two-tenths of a link south-westerly for three chains twelve links and two-tenths of a link along the said land sold to the said William James Little and for ten chains eighteen links along other part of the said fifty-seven acres two roods nine perches sold to Beryl Potter and thence on the south-west by eleven chains thirty links north-westerly along the Patterson's Plains Road here now called the Penguite Road to the corner formed by that road and Hobbler's Bridge Road and thence crossing the lastmentioned road to the point of commencement. The same forming portion of the land described in Section Fortvseven of the 1924 Act, in that Act and this Act referred to as the new Area.

4. The provisions of the said Part IX. of the 1924 Act shall continue to apply to the remainder of the new area as if the new area had originally consisted of the land described in Section Forty-seven of the 1924 Act less the portion thereof which is included within the boundaries of the City in accordance with Section Three of this Act. And with regard to that portion so included in accordance with Section Three of this Act, the provisions of the said Part IX. of the 1924 Act shall also separately apply to that portion, the said thirtieth day of June, one thousand nine hundred and twenty-eight, being considered as the inclusion day and that portion being considered as the new area for this purpose.

Amendment of Section 49 of 15 Geo. V. No. 59. 5 The words "one thousand nine hundred and thirty-four" occurring in the first and second lines of Section Forty-nine of the 1924 Act are hereby expunged.
