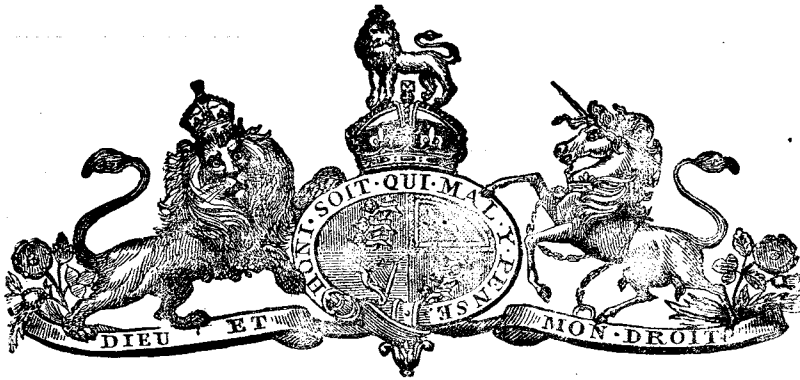

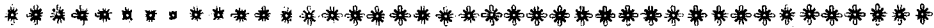

AN ACT to amend "The *Longford* Lighting Act, 1903," and to repeal "The *Longford* Lighting Act Amendment Act, 1905."

BE it enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

1 This Act may be cited as "The *Longford* Lighting Amendment Act, 1908," and shall be deemed to be incorporated with and construed as one with "The *Longford* Lighting Act, 1903," hereinafter called the Principal Act.

2 Section Four of the Principal Act is hereby amended—
1. By repealing the definition "Trustees," and substituting the following definition, namely :—" ' Trustees ' means the Warden and Councillors of the Municipality of *Longford*

4 Parts II. and III. of the Principal Act, and Schedules (1.), (2.), and (3.) to that Act, are hereby repealed.

5 Section Forty of the Principal Act is hereby amended by repealing the word "Board" in line Three, and substituting therefor the word "Trustees."

6 The Warden and Councillors of the Municipality of *Longford* who from time to time constitute the Municipal Council of the said Municipality are hereby constituted and declared to be the trustees of the Light District for all the purposes of the Principal Act.
