

AN ACT to enable the Mayor, Aldermen, and Citizens of the City of Launceston to borrow certain Sums of Money for various purposes.

[31 March, 1924.]

A.D. **1924.** 

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1 This Act may be cited as "The Launceston Loans for Various Short title. Purposes Act, 1924."
  - 2 In this Act, unless the context otherwise indicates—

Interpretation.

- "The Corporation" means the Corporation and body politic of the Mayor, aldermen, and citizens of the City of
  - "The Council" means the Municipal Council of the City of Launceston:

## Launceston Loans.

A.D. 1924.

Power to borrow £50,000 for general purposes. 7 Geo. V. No. 10. 9 Geo. V. No. 45,

3 It shall be lawful for the Corporation, from time to time, to borrow and take up at interest such further sum or sums of money, not exceeding the sum of Fifty thousand Pounds, as shall, by the Council, be deemed requisite for any purpose or purposes mentioned in Section Three of "The Launceston General Purposes Loans Act, 1916," and Section Five of "The Launceston Corporation Act Amendment Act, 1918, No. 2," in addition to the sum of Sixty thousand Pounds mentioned in the said Section Three and the sum of Twenty-five thousand Pounds mentioned in Section Nine of "The Launceston Corporation Act Amendment Act, 1918, No. 2."

And "The Launceston General Purposes Loans Act, 1916," shall be read and construed as if the total amount thereby authorised to be borrowed was One hundred and thirty-five thousand Pounds instead of

Eighty-five thousand Pounds

Power to borrow £50,000 for water purposes.

4 It shall be lawful for the Corporation, from time to time, to borrow and take up at interest such further sum or sums of money, not exceeding the sum of Fifty thousand Pounds, as shall by the Council be deemed requisite for any purpose or purposes mentioned in 6 Geo. V. No. 11. Section Three of "The Launceston Water Loans Act, 1915," in addition to the sum of One hundred thousand Pounds mentioned in the said Section Three of the lastmentioned Act.

And "The Launceston Water Loans Act, 1915," shall be read and construed as if the total amount thereby authorised to be borrowed was One hundred and fifty thousand Pounds instead of One hundred thousand Pounds.

Power to borrow £50.000 for sewerage purposes.

5 It shall be lawful for the Corporation, from time to time, to borrow and take up at interest such further sum or sums of money not exceeding the sum of Fifty thousand Pounds, as shall by the Council be deemed requisite for any purpose or purposes mentioned in Section Five of "The Launceston Sewerage Act, 1914," in addition to the sum of Ninety thousand Pounds mentioned in the said Section Five of the lastmentioned Act.

And "The Launceston Sewerage Act, 1914," shall be read and construed as if the total amount thereby authorised to be borrowed was One hundred and forty thousand Pounds instead of Ninety thousand Pounds.

Power to borrow £50,000 for electrical purposes.

6 It shall be lawful for the Corporation, from time to time, to borrow and take up at interest such further sum or sums of money not exceeding the sum of Fifty thousand Pounds, as shall by the Council be deemed requisite for the purpose of supplying light, heat, and motive power to the inhabitants of the City of Launceston and other places, under and in accordance with the provisions of "The Launceston Water and Light Act, 1895," in addition to the sums following (that is to say)—

Fifty thousand Pounds mentioned in Section Sixty-seven of the lastmentioned Act.

Twenty thousand Pounds mentioned in Section One of "The 9 Ed. VII. No. 21. City of Launceston Loans Act, 1909."

Fifty thousand Pounds mentioned in Section One of "The 10 Geo. V. No. 30. City of Launceston Electricity Loans Act, 1919."

And the provisions of Part X. of "The Launceston Water and Light Act, 1895," together with the provisions of Sections Six and Seven of "The Launceston Water and Light Act, No. 2," shall be 59 Vict. No. 52. read and construed as if the total amount authorised to be borrowed for the purpose of supplying light, heat, and motive power as aforesaid was Two hundred and eighty thousand Pounds instead of Two hundred and thirty thousand Pounds (as it now is by virtue of the beforementioned Acts) and accordingly Section Sixty-seven of "The Launceston Water and Light Act, 1895," shall hereafter be read as it the amount inserted therein were Two hundred and eighty thousand Pounds instead of Fifty thousand Pounds. The other Acts mentioned in this section shall not be considered on this account to authorise the borrowing of more than a total sum of Two hundred and eighty thousand Pounds.
