AN ACT to amend the Maintenance Act, 1921. [14 December, 1931.]

A.D. **1931.**

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as "The Maintenance Act, 1931."

Short title.

- 2 The Maintenance Act, 1921, is hereby amended—
- Section 3.

I. As to Section Three thereof—

- (a) By inserting after the definition of "Maintenance order" the following definition:—
 - "' Means of support' or 'adequate means of support' means such means of support as are sufficient, having regard to the means and condition in life of the parties."

- (b) By expunging the definition of "Other State" in Section Three and substituting therefor the following definition:-
 - "'Other State' in Part III. means any State of the Commonwealth, and any Territory under the authority of the Commonwealth or governed by the Commonwealth under a mandate, in respect of which a proclamation under Section Twentyseven has been issued and is in force: ":

- II. By expunging Subsection (2) of Section Seventeen thereof:
- III. As to Section Twenty-seven thereof—
 - (a) By deleting the words "or Dominion of New Zealand" in the first and second lines of Subsections (1) and (2);

(b) By deleting the words "or Dominion" wherever

occurring in that section;

- (c) By deleting the word "Forty-six" in the fifth line of Subsection (2) and substituting therefor the word "Forty-five"; and
- (d) By adding at the end of that section the following subsection:-
- "(8) For the purposes of this Part 'State' includes a Territory under the authority of the Commonwealth and a Territory governed by the Commonwealth under a mandate.": and

New Division V. in Part III.

- IV. By inserting after Section Forty-eight the following new Division V.:-
 - "Division V.—Enforcement of Orders for Maintenance Confirmed under any Statute Reciprocal to the Maintenance Orders (Facilities for Enforcement) Act, 1920 (10 and 11 Geo. V., c. 33).
 - "48a-(1) The provisions of this Part shall extend to the enforcement in this State of a maintenance order confirmed under any statute reciprocal to the Imperial Act intituled 'The Maintenance Orders (Facilities for Enforcement) Act, 1920,' by a court in any other State, and of any order made by any court in that State to enforce a maintenance order so confirmed.
 - (2) Any such order may be enforced under this Part in the same manner as a maintenance order made by a court in any other State.".
