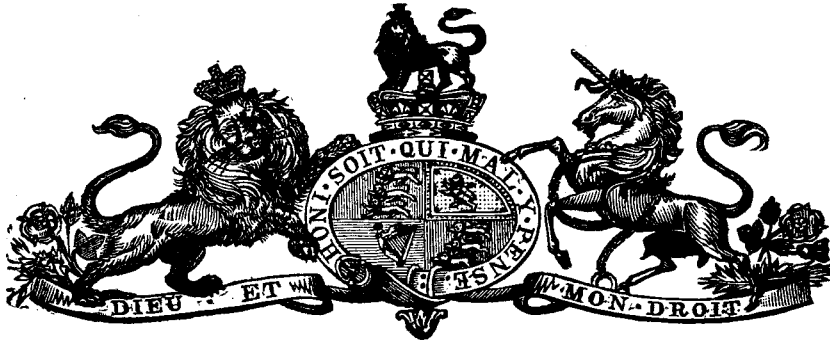

AN ACT to vest certain Properties in certain A.D. 1890.
Marine Boards, and for other purposes.

[2 October, 1890.]

BE it enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

1 This Act may be cited as “ The Marine Boards Act, 1890.” Short title.

2 All property, real or personal, and all rights and privileges whatsoever, vested in or possessed by “ The *Hobart* Marine Board ” on the Thirtieth day of *November* in the year 1889, are hereby declared to have become vested in “ The Marine Board of *Hobart* ” on the First day of *December* in the year 1889. Property vested in Marine Board of *Hobart*.

3 All property, real or personal, and all rights and privileges whatsoever, vested in or possessed by “ The *Launceston* Marine Board ” on the Thirtieth day of *November* in the year 1889, are hereby declared to have become vested in “ The Marine Board of *Launceston* ” on the First day of *December* in the year 1889. Property vested in Marine Board of *Launceston*.

4 All property, real or personal, and all rights and privileges whatsoever, vested in or possessed by "The *Mersey* Marine Board" on the Thirtieth day of *November* in the year 1889, are hereby declared to have become vested in "The Marine Board of *Mersey*" on the First day of *December* in the year 1889.

Property vested
in Marine Board
of *Table Cape*.

5 All property, real or personal, and all rights and privileges whatsoever, vested in or possessed by "The *Table Cape* Marine Board" on the Thirtieth day of *November* in the year 1889, are hereby declared to have become vested in "The Marine Board of *Table Cape*" on the First day of *December* in the year 1889.

Property vested
in Marine Board
of *Circular
Head*.

6 All property, real or personal, and all rights and privileges whatsoever, vested in or possessed by "The *Circular Head* Marine Board" on the Thirtieth day of *November* in the year 1889, are hereby declared to have become vested in "The Marine Board of *Circular Head*" on the First day of *December* in the year 1889.

Amendments of
53 Vict. No. 34.

7 The following amendments are hereby made in the several Sections and Schedule (2.) of "The Marine Boards Act, 1889," and such Sections and Schedule shall be read and construed as if such amendments had always been made therein :—

The words "the Act" in the Fourth line of Section One hundred and seventy-five are hereby expunged, and in lieu thereof the words "this Act or of any Act hereby repealed" are hereby inserted.

At the end of Sub-section III. of Section One hundred and seventy-nine, the words "of the Court of Enquiry" are hereby added.

In the Schedule (2.), the words "on the Western Coast of *Tasmania*" are hereby inserted after the word "Latitude" in the declaration of the jurisdiction of "The Marine Board of *Hobart*."

Acts to be read
together.

8 This Act and "The Marine Boards Act, 1889," shall be read and construed together as one Act.
