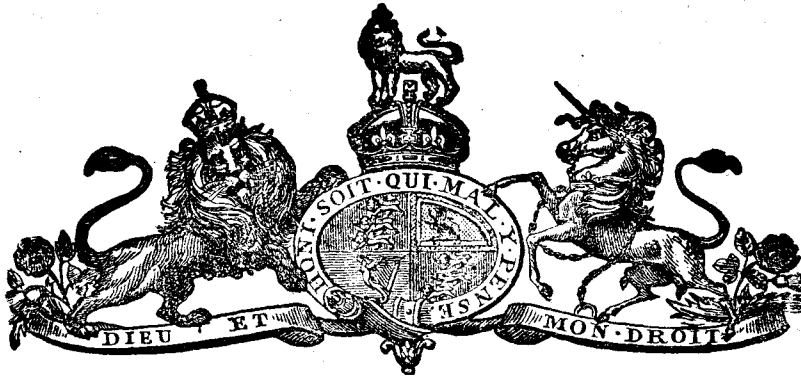

ANALYSIS.

- 1. Short title and incorporation with 1 Geo. V. No. 68, 7 Geo. V. No. 17, and 10 Geo. V. No. 31.
- 2. Board may expend £500 out of moneys advanced in erection of a signal tower at Burnie.

AN ACT to authorise the expenditure by the Marine Board of Burnie and Table Cape of Five hundred Pounds out of certain borrowed moneys in the Erection and Equipment of a Signal Tower for the Port of Burnie.

WHEREAS under the authority of "The Marine Board of Burnie and Table Cape Loan Act, 1910," a loan of One hundred and twenty thousand Pounds has been granted to the Marine Board of Burnie and Table Cape for the purpose of extending the harbour accommodation of the Port of Burnie by the erection of a breakwater and wharves, and for the purpose of defraying the expense thereof, and of acquiring the necessary land in connection therewith :

And whereas under the authority of "The Marine Board of Burnie and Table Cape Loan Act, 1916," a further loan of Eighty thousand Pounds has been granted to the Marine Board of Burnie and Table Cape for the above purposes :

And whereas under the authority of "The Marine Board of Burnie and Table Cape Loan Act, 1919," a further loan of Twenty thousand Pounds has been granted to the Marine Board of Burnie and Table Cape for the above purposes :

And whereas it is expedient that a signal tower for the Port of Burnie should be erected on land at Burnie within the jurisdiction of the Marine Board of Burnie and Table Cape out of moneys already advanced under the abovementioned Acts :

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

Short title and incorporation with 1 Geo. V. No. 68, 7 Geo. V. No. 17, and 10 Geo. V. No. 31.

1 This Act may be cited as "The Marine Board of Burnie and Table Cape Loan Act, 1921," and shall be incorporated and read as one with "The Marine Board of Burnie and Table Cape Loan Act, 1910," "The Marine Board of Burnie and Table Cape Loan Act, 1916," and "The Marine Board of Burnie and Table Cape Loan Act, 1919" (hereinafter referred to as the Principal Acts).

Board may expend £500 out of moneys advanced in erection of signal tower at Burnie.

2 It shall be lawful for the Marine Board of Burnie and Table Cape to apply, expend, and lay out such sum or sums of money as the Board may determine not exceeding in the aggregate Five hundred Pounds out of moneys advanced to the Board under the provisions of the Principal Acts in and towards the erection and equipment of a signal tower for the Port of Burnie, on such land within the jurisdiction of the Board as the Board may deem fit.
