

# ANNO QUADRAGESIMO-OCTAVO

### VICTORIÆ REGINÆ,

No. 16.

AN ACT to enable certain Mining Companies A.D. 1884. to sue and be sued in Tasmania.

[24 November, 1884.]

**B**E it enacted by His Excellency the Governor of *Tasmania*, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

- 1 This Act may be cited as "The Mining Companies (Foreign) Short title. Act."
- 2 This Act shall commence and take effect from and immediately Commencement. after the Thirtieth day of November, One thousand eight hundred and eighty-four.
  - 3 In this Act, unless the context otherwise determines—

Interpretation.

- "Company" includes any association, partnership, or co-adventure:
- "Gazette" means The Hobart Gazette.
- Every Company formed or incorporated in any country or place Company formed beyond this Colony and carrying on mining operations in this Colony, out of this Colony such Company not being registered under "The Mining Companies for mining in this Colony may sue and be sued in its corporate name in Tasmania; and be sued in and the liability of and proceedings against such Company shall, subject Tasmania. to the provisions of this Act, be the same as if such Company had been duly registered in Tasmania under the said Act.

#### Mining Companies (Foreign).

Company to register name of Agent and situation of office.

5 Every such Company before commencing mining operations shall register the names and place of abode or business of the person appointed by such Company to carry on the business of such Company in Tasmania, and also the situation of the office of such Company in this Colony; and the person so registered shall be deemed to be the Agent of such Company, and such office shall be the Registered Office of such Company for the purposes of this Act and the said Act.

Every Company which fails to comply with this provision shall be liable to a penalty not exceeding Five Pounds for every day during

which mining operations shall be carried on.

Mode of registration.

6 The Registration of such Agent and Office shall be effected in the following manner:—The duly appointed Attorney of such Company shall make and sign a Declaration in the form in the Schedule (1.), or to the like effect, before a Justice of the Peace, and such Declaration when so made and signed shall be published in the Gazette, in some newspaper published in Hobart, and some newspaper published in Launceston, and copies of such Gazette and newspapers shall be forwarded to and be retained by the Secretary of Mines.

Every person who wilfully makes any such Declaration falsely in any particular shall be guilty of a Misdemeanor, and on conviction thereof be liable to be imprisoned for any term not exceeding Two years.

Proof of registration. Schedule (2.) 7 A certificate in the form or to the effect in the Schedule (2.), purporting to be under the hand of the Secretary of Mines (who is hereby required to give such certificate to any person applying for the same on payment of One Shilling), and which certificate shall set forth the name of the Agent of, and the situation of the Office of the Company in Tasmania, shall be primā facie evidence in all Courts that the person named therein as Agent is the Agent of such Company in Tasmania, and that the Office of such Company in Tasmania is situate as therein stated, and that such Agent and Office have been duly registered under the provisions of this Act, and of the time of registration, and of all other particulars mentioned in such certificate.

Registration under 44 Vict. No. 19.

8 Every Company which shall have effected the Registration of the Agent and the Office of such Company in *Tasmania* in accordance with the provisions of the Act of the Parliament of *Tasmania* of the 44th *Victoria*, No. 19, shall, from and after the commencement of this Act, be deemed and taken to have effected the Registration of such Agent and Office under this Act.

Notice of removal of office or substitution of Agent to be given

**9** When and so often as any such Registered Office shall be removed, or any other person shall be substituted for the registered Agent of such Company, the like Declaration and notice shall be made and given as is hereinbefore required with reference to the registration of a Company; and if the requirements of this section shall not be complied with such Company shall be liable to a penalty of Five Pounds.

Service of notices, &c.

10 All communications and notices may be addressed to the Registered Office of such Company, and service of any notice or legal process at such office shall be deemed to be service upon the Company; and any Company which carries on business without having a Registered Office shall be liable to a penalty not exceeding Five Pounds for every day during which the business is so carried on.

#### Mining Companies (Foreign).

11 Every contract made by the Agent for the time being of any such A.D. 1884. Company for the purchase of goods or the performance of work, and the Contracts made supply of the materials for the same for the purposes of such Company, by the Agent to shall be binding upon such Company and upon the assets thereof as be binding on the herein provided, and such assets may be seized and sold in execution in Company. any action against such Company upon any such contract.

12 Contracts on behalf of any such Company may be made, varied, Contracts how or discharged as follows (that is to say):-

made, varied, or discharged.

i. Any contract which, if made between private persons, would be by law required to be in writing under seal, may be made varied, or discharged in the name and on behalf of the Company in writing under the hand of the Agent of such Company:

ii. Any contract which, if made between private persons, would be by law required to be in writing and signed by the parties to be charged therewith, may be made, varied, or discharged in the name and on behalf of the Company in writing signed by the Agent of such Company:

iii. Any contract which, if made between private persons, would by law be valid although made by parol only and not reduced into writing, may be made, varied, or discharged by parol in the name and on behalf of the Company by the Agent of such Company.

13 The Agent of every such Company shall make and publish in the Accounts to be Gazette in the months of January and July respectively in each year periodically a full and correct account of the assets and liabilities of such Company, published. and if such account is not published as herein required such Agent shall be liable to a penalty not exceeding Fifty Pounds.

14 No person shall commence to carry on or carry on mining operations Penalty on in Tasmania or enter into any contract or agreement with any other person persons carrying or Company in *Tasmania* for or on behalf of or in the name of any on operations for such Company as is described in the Fourth Section of this Act which has not complied with the provisions contained in the Fifth Section of has not complied with the provisions contained in the Fifth Section of Companies. this Act; and every person who offends against this Section shall be liable to forfeit and pay a penalty not exceeding Twenty Pounds and not less than Five Pounds.

15 All penalties imposed by this Act may be recovered before any Recovery of two Justices in the mode prescribed by The Magistrates' Summary penalties. Procedure Act.

16 The Act of the Parliament of Tasmania of the 44th Victoria, Repeal. No. 19, is hereby repealed; but such repeal shall not affect anything 44 Vict. No. 19. duly done thereunder or any rights acquired or liability incurred before the commencement hereof, and such rights and liabilities may be enforced and prosecuted as if this Act had not been passed.
