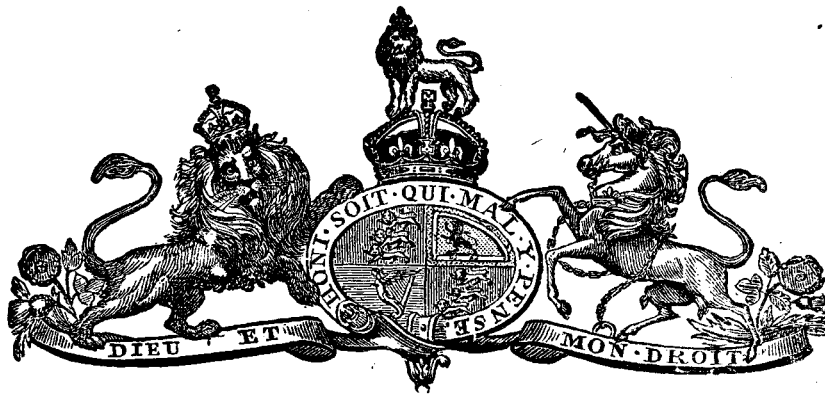

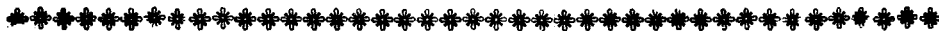

AN ACT to further amend "The North-Eastern Harbour Trust Act, 1913," and for other purposes. [23 December, 1918.]

WHEREAS it is desirable to further amend "The North-Eastern Harbour Trust Act, 1913" (as amended by the Act 7 Geo. V. No. 53), by further increasing the amount which may be granted by the Governor as a loan to the North-Eastern Harbour Trustees for the purposes of "The North-Eastern Harbour Trust Act, 1913," from Three thousand two hundred and fifty Pounds to Three thousand seven hundred and fifty Pounds :

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

Short title and incorporation with 4 Geo. V. No. 25.

**1** This Act may be cited as "The North-Eastern Harbour Trust Act, 1918," and is hereby incorporated with and shall be read as one with "The North-Eastern Harbour Trust Act, 1913," (hereinafter referred to as the Principal Act) and any amendment thereof.

Amendment of Sections 21, 22, and 29 of 4 Geo. V. No. 25 as amended by Section 1 of 7 Geo. V. No. 53.

**2** Sections Twenty-one, Twenty-two, and Twenty nine of the Principal Act, as amended by the Act 7 Georgii V. No. 53, are hereby further amended by omitting from each of the said sections the words "Three thousand two hundred and fifty Pounds" wherever occurring therein, and substituting for the words so omitted the words "Three thousand seven hundred and fifty Pounds."

Previous poll to be sufficient.

**3** The poll taken on the Thirteenth day of November, One thousand nine hundred and fifteen, is hereby declared to be sufficient for the purposes of the Principal Act as amended by this Act.

No further plans, &c., necessary.

**4** No plans and specifications or report by the State Engineer-in-Chief shall be required to be submitted pursuant to Section Twenty-three of the Principal Act with respect to the increased loan under this Act.

Terms and conditions.

**5** The loan authorised by this Act shall be made on and subject to such other terms and conditions as the Governor may impose or approve in all respects.

Repeal of Sections 1 and 2 of 7 Geo. V. No. 53.

**6** Sections One and Two of the Act 7 Georgii V. No. 53 are hereby repealed.
