6. Repeal of Sections 1 and 2 of 7 Geo. V. No. 53

AN ACT to further amend "The North-Eastern Harbour Trust Act, 1913," and for [23 December, 1918.] other purposes.

WHEREAS it is desirable to further amend "The North-Eastern PREAMBLE Harbour Trust Act, 1913" (as amended by the Act 7 Geo. V. No. 53), by 4 Geo. V. No. 25. further increasing the amount which may be granted by the Governor as a loan to the North-Eastern Harbour Trustees for the purposes of "The North-Eastern Harbour Trust Act, 1913," from Three thousand two hundred and fifty Pounds to Three thousand seven hundred and fifty Pounds :

5 The loan authorised by this Act shall be made on and subject to such other terms and conditions as the Governor may impose or approve in all respects.

6 Sections One and Two of the Act 7 Georgii V. No. 53 are tions 1 and 2 of 7 hereby repealed. Geo. V. No. 53.

Be it therefore enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :----

1 This Act may be cited as "The North-Eastern Harbour Trust Act, 1918," and is hereby incorporated with and shall be read as one with "The North-Eastern Harbour Trust Act, 1913," (hereinafter referred to as the Principal Act) and any amendment thereof.

2 Sections Twenty-one, Twenty-two, and Twenty nine of the Principal Act, as amended by the Act 7 Georgii V. No. 53, are hereby further amended by omitting from each of the said sections the words "Three thousand two hundred and fifty Pounds" wherever occurring therein, and substituting for the words so omitted the words "Three thousand seven hundred and fifty Pounds.

3 The poll taken on the Thirteenth day of November, One thousand nine hundred and fifteen, is hereby declared to be sufficient for the purposes of the Principal Act as amended by this Act.

4 No plans and specifications or report by the State Engineer-in-Chief shall be required to be submitted pursuant to Section Twentythree of the Principal Act with respect to the increased loan under this Act.
