

AN ACT to amend the Official Salaries Reduction Act, 1931. [14 December, 1931.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :--

• 1 This Act may be cited as "The Official Salaries Reduction Act (No. 2), 1931."

2 The Official Salaries Reduction Act, 1931, is hereby amended—

I. By inserting after the word "Act" in the third line of Section 4. Paragraph III. of Section Four thereof the words "except as provided by Section Ten hereof":

A.D. 1931.	Section 8 (1).	II. By deleting from the second and third lines of Subsection (1) of Section Eight thereof the words—"which is a hospital, and the University, and any other such institu- tion":
	Section 8 (3).	III. By inserting after the word "effect" at the end of Subsection (3) of Section Eight thereof the words—"Provided that, where a proclamation in respect of any institution is made under this section after the first day of August, one thousand nine hundred and thirty-one, the provisions of Subsection (2) of Section Five shall be applied as if the date of such proclamation were substituted for the words above quoted":
		IV. As to the proviso to Division (2) of the schedule thereto-
		(a) By inserting after the word "month" in the fourth line of Paragraph 11. thereof the words—"but no such allowance shall be made to any officer as defined in Paragraph 111. of the definition of 'Officer' in Section Three of the Act": and
		(b) By adding after Paragraph v11. thereof the following new Paragraphs v11., 1x., and x.—
		"viii. A married female officer whose duties require her attendance during all ordinary hours of duty and who is separated from and not supported by her husband and who has dependants shall receive a marriage allowance as provided by Paragraph 11. hereof:
		1x. Where an officer's salary since the first day of July, one thousand nine
		hundred and thirty, has been reduced under or in pursuance of any other Act, and remains subject to such reduction, the total reduction to be made in such salary under this Act and such other Act shall not exceed the percentage applicable thereto under this Act :
		x. The provisions of Paragraph 1. of this proviso shall be applied without refer-
		ence to any allowance payable under Paragraph II. thereof, but so that the combined operation of those two para-
		graphs shall not in any case have the effect of increasing the aggregate amount payable to any officer beyond the normal salary to which, but for this Act, he would be entitled ":

Official Salaries Reduction (No. 2).

V. By inserting the figure (1) before the word "Nothing" at Section 10. A.D. 1981. the beginning of Section Ten thereof, and by adding at the end of that section the following new Subsection (2) :---

"(2) The provisions of this section shall be applied in respect of any person employed by or on behalf of the State whose remuneration is paid at a rate determined, in relation to him, under the provisions of a Commonwealth Act, and who is subject to a reduction of Ten Pounds per centum, effected under or in pursuance of an award of the Commonwealth Court of Conciliation and Arbitration made on the twenty-second day of January, one thousand nine hundred and thirty-one, as if he were an officer and such reduction had been made under this Act, and this provision shall apply in respect of every officer who has retired after the date on which his salary was so reduced as aforesaid."

3 The amendments hereinbefore contained shall have effect, and be deemed at all times to have had effect, as from the twenty-fifth day of July, one thousand nine hundred and thirty-one.
