

AN ACT to provide for the Suspension of certain Contributions to the Commissioners of the Public Debts Sinking Fund in respect of the Financial Years 1927-28 and 1928-29, and for other purposes.

[22 December, 1927.]

BE it enacted by His Excellency the Governor of Tasmania by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as "The Public Debts Sinking Fund Short title and Contributions Suspension Act, 1927," and shall come into operation commencement, on a day to be fixed by proclamation.

Interpretation. 45 Vict. No. 15. 2 In this Act, unless the context otherwise indicates or requires—

"The Commissioners" means the Commissioners of the Public Debts Sinking Fund constituted under the Public Debts Sinking Fund Act, 1881:

"The financial agreement" means the agreement, dated the twelfth day of December, one thousand nine hundred and twenty-seven, made between the Commonwealth of the first part and the States of New South Wales, Victoria, Queensland, South Australia, Western Australia, and Tasmania, of the second, third, fourth, fifth, sixth, and seventh parts respectively, and a copy of which is set out in the schedule to the Financial Agreement Act, 1927:

"The National Debt Commission" means the National Debt Commission constituted under the National Debt Sinking

Fund Act, 1923-25, of the Commonwealth.

3 Notwithstanding any law to the contrary, during the financial years ending, respectively, on the thirtieth day of June, one thousand nine hundred and twenty-eight, and the thirtieth day of June, one thousand nine hundred and twenty-nine, no contributions shall be made by the Treasurer out of the Consolidated Revenue to the Commissioners or to any other person or persons whatsoever, of any sum or sums of money for the purpose of redeeming any moneys-

Provided, however, that the foregoing provision of this section shall not apply to, or in respect of, any moneys forming part of such gross public debt as aforesaid, and represented by local inscribed stock created or issued by the Treasurer under the authority conferred upon

4 In lieu of the contributions referred to in Section Three of sinking fund con- this Act, the Treasurer shall, in each of the financial years in that section mentioned, pay out of the Consolidated Revenue to the National Debt Commission, sinking fund contributions in respect of the moneys referred to in Paragraphs 1. and 11. of the said section, in accordance with the provisions of the financial agreement.

> 5 Notwithstanding anything to the contrary in the Mount Cameron Water-race Act, 1926, during the financial years ending, respectively, on the thirtieth day of June, one thousand nine hundred and twentyeight, and the thirtieth day of June, one thousand nine hundred and twenty-nine, no moneys at any time standing to the credit of the suspense account, referred to in Subsection (5) of Section Five of the lastmentioned Act, shall be paid by the Treasurer to the Commis

sioners as directed by the said subsection; but the Treasurer shall, as A.D. 1927 soon as practicable after the commencement of each of the financial years aforesaid, pay into the Consolidated Revenue the moneys, if any, standing to the credit of the said suspense account at the end of the immediately preceding financial year.
