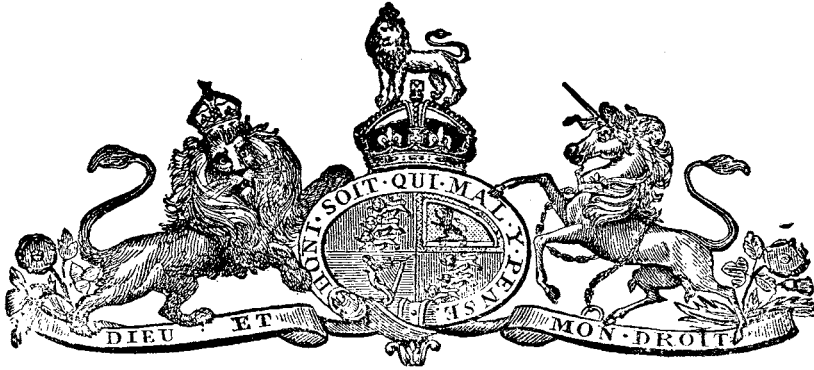

AN ACT to further amend "The Public Works Committee Act, 1914."

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows:—

1 This Act may be cited as "The Public Works Committee Act, 1917," and shall be construed as one with "The Public Works Committee Act, 1914" (hereinafter referred to as "the Principal Act"), and every amendment thereof.

Public Works Committee Amendment.

2 Subsection Two of Section Four of the Principal Act is hereby amended, and the following is substituted therefor :—

“(2) Where a vacancy occurs in the Committee, it shall be filled by appointment as aforesaid, within the next Thirty sitting days of the House of Assembly, occurring after the happening of the vacancy. Provided that if the vacancy arises when the Parliament is not in session, or, if the vacancy having arisen when the Parliament was in session remains unfilled when the Parliament is not in session, the Governor shall appoint a Member of Parliament to temporarily fill the vacancy until it shall be filled by appointment as aforesaid within the said Thirty sitting days.

“In this subsection ‘sitting days’ means days on which the House of Assembly actually sits. This subsection shall apply notwithstanding that the said Thirty sitting days, or some of them, do not occur in the same session ”

3 The present Joint Committee holding office under the Principal Act is hereby dissolved.

Fresh Committee
appointed.

4 In place of the said Committee so dissolved, the following persons, namely :—

are hereby appointed a Joint Committee under the Principal Act, and (subject to the provisions of Section Four of that Act) shall hold office for the duration of the present House of Assembly, as if duly appointed in accordance with the provisions of Section Three of the Principal Act.
