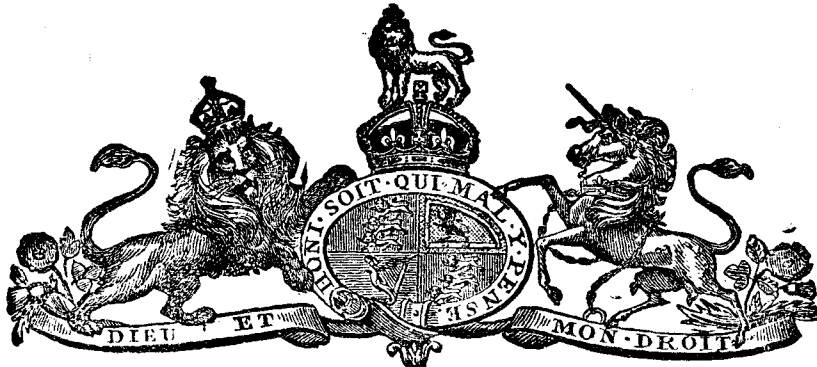

AN ACT to provide for the Execution of A.D. 1931.
 certain Public Works. [14 December, 1931.]

BE it enacted by His Excellency the Governor of Tasmania, by and with the advice and consent of the Legislative Council and House of Assembly, in Parliament assembled, as follows :—

1 This Act may be cited as “The Public Works Execution Act, Short title. 1931.”

Public Works Execution.

A.D. 1931.

Minister may cause works in schedules to be carried out.

Application of 44 Vict. No. 32 and 45 Vict. No. 31.

Optional application of 1 Geo. V. No. 11 or 58 Vict. No. 17.

Power to Treasurer to borrow £11,000.

2 It shall be lawful for the Minister to cause to be undertaken, executed, and carried out the works specified in Schedules (1) and (2) to this Act at a cost not exceeding in respect of any item so specified the sum set forth in the said schedules in respect thereof.

3 The provisions of the Public Works Construction Act, 1880, and the Branch Roads Construction Act, 1881, shall extend and apply to the works mentioned in the schedule as fully in all respects as if the said provisions had been incorporated in this Act.

4 At the option of the Minister any land required for the purpose of any public work authorised by this Act may be purchased, acquired, or taken under the Lands Resumption Act, 1910, or the Land Vesting Act, 1894, and in the event of such option being exercised in respect of either of those Acts, for the purposes of such work, the provisions of such Act shall be deemed to be incorporated with this Act in lieu of the provisions of the Acts mentioned in Section Three hereof.

5 It shall be lawful for the Treasurer to raise, borrow, and receive for the purposes of this Act any sum or sums of money, not exceeding in the whole the sum of Eleven thousand Pounds.
